I am handing you herewith copy of the petition received from the Senece Club of Tample University, Philadelphia, Pennslyvania, together with the historical record of each petitioner, a report from Brothers Edgar and Makay and the approval of the Chairman of the Extension Committee, Brother Hoyt.

The writer has been negotiating with the Senece Club for a couple of months and the latter partof November, appointed Brother Edgar, a member of the Board of Directors, as Chairman of a Committee the members of which he was to select himself, to make a trip of investigation to Philedelphie. He selected Brother Makey, also a member of the Board of Directors and one of the founders of the fraternity, to make this trip with him, which trip they make on December 16th. The Senece Club held an informal meeting in the afternoon, a benquet in the evening and a formal meeting afterwards.

About the same time, I had been corresponding with Dean Johnson of the Wharton School of Commerce, Accounts and Finance of the University of Pennsylvania, also situated in Philadelphia. I had Brothers Edgar and Makey interview Dean Johnson at the same time.

The reports of Brothers Edger and Makey, I think, is very complete. It covers the situation thoroughly and I am most heartily in favor of granting a chapter to Temple University and accepting the petition of the Senece Club. As you will see from this report, they have likened the situation to that existing at New York, in relation to New York and Columbia Universities, and here in Chicago, in connection with Northwestern and Chicago Universities. Columbus, Wherton and Chicago are all wealthy universities with many influential collegiste fraternities in existant, drawing their membership from all schools. While they have fairly large schools of commerce, they specialize to a great extent in graduate work, and while there would be considerable prestige for Delte Sigma Pi to be able to include these schools on our chapter roll and it is hoped that sometime in the years to come although not very soon, this will be possible, it is evident that the group of man comprising the Senece Club will develope into equally as strong a chapter at Temple as Alpha is at New York and Beta is at Northwestern, proportionshely speaking.

Temple University was founded in 1884 and is one of the largest institutions in the country, having in 1921 over 8100 students and the registration in the School of Commerce is approximately three thousand. It is not very well known in the West but their scholastic requirements are of the very highest and they offer both courses in the day and the evening. Their curriculum is very complete including 16 courses in Accounting, 5 in Advertising and Modern Seles Management, 7 in Commercial Law, 6 in Economics, 18 in English, 5 in Finance, 6 in Foreign Trade, 5 in French, 4 in German, 15 in History, 3 in Insurance, 10 in Journalism, 5 in Marketing, 5 in Mathematics, 6 in Organization and Management, 4 in Policical Science, 4 in Sociology, 4 in Spanish and 3 in Transportation. Their courses lead to a degree of Bachelor of Science in Commerce (B.S.C.) and to receive this degree, one must have completed 128 semester oredits, 4 of which are in Physical education. A High School education is required.

I most heartily approve the soceptance of the petition of the Senece Club and I ask that you indicate your approval of (1) the granting of a chapter of Delta Sigma Pi to Temple University School of Commerce, Philedelphia, Pennsylvania, and (2) the acceptance of the petition of the Senece Club to be installed as our Omege Chapter. (In this connection, I might state that the Wisconsin patition was received first and that group will be installed before this group can be installed and they will therefore receive preference on the Greek letter Pei which is sheed of Omega.)

REPORT ON INVESTIGATION OF SENECA CLUB

OF TEMPLE UNIVERSITY.

Philadelphia, Pa.

PURPOSE AND HISTORY:

The Seneca Club was founded in 1919 by a group of day students in the School of Commerce of Temple University for the purpose of promoting social life in the school and to stimulate interest and study of business. Of the Original founders of the Club, six members are still in school and actively engaged in carrying out iss purpose.

PERSONNEL:

The Club membership at present is comprised of twenty one active members, each one a factor in school affairs. The attached statement covering each member's history, scholastic rating and activities engaged in will substantiate the above statement.

Included among the present active members of the Seneca Club is Professor Cochran who acts as Faculty adviser. Prof. Cochran attends all Club meetings and also has passed on the scholastic standing and personal characteristics of every member of the Club and will continue to approve all proposed members in the future. This exacting method of selecting members is responsible for the present high standard of the Club's members and typifies the sound principles on which the club is conducted.

It will be noticed that the Club is comprised of an unusually mature body of men, their ages averaging twenty five years or over. They impressed us as being sound thinkers, and exceedingly earnest workers. Our opinions were confirmed by Prof. Cochran's report on each member. These men go into whatever they attempt whole-heartedly, whether in the interests of the school or their own organization. They give full support to all school affairs voluntarily.

FUTURE OUTLOOK FOR A CHAPTER IN TEMPLE UNIVERSITY:

1-Unity of Purpose of Seneca Club:

The members of the Seneca Club are absolutely sincere in their motive in petitioning us and as far as could be ascertained our fundemential purposes are alike. We are convinced that they would work incessantly to uphold our ideals and further our interests.

2- Faculty Support:

The motive of the Seneca Club members in petitioning us for the privilege to operate as a chapter is genuine. They do not have to be sold on the merits

Several infulential members of the faculty of Temple University who know of our organization, apparently through Dr. Galloway, sanction without reservation their affiliation with us, recommended that they petition us. Dr. Dunhoum and Prof. Cochran may be numbered among those who have boosted Delta Sigma Pi of their own volition. These men and other professors and department heads will gladly accept membership in the chapter at Temple University if we grant a charter to the Seneca Club.

THE PHILADELPHIA SITUATION:

We find ourselves in the rather delicate position of having to make our selection between the two universities in Philadelphia as a place to establish a Chapter. If Temple University was the only school in the city. our recommendation would be for granting the Seneca Club a charter without further consideration. However, there is no denying the desirability from the standpoint of public opinion of establishing a Chapter at the University of Fernsylvania. Comparatively speaking, you have covered the essential feature of the Wharton School when you mention the prestige of the latter over Temple. It would not be possible to organize and develop in the University of Pennsylvania, a group with the same serious intent and capabilities as the petitioning group at Temple. A professional frathernity, we were told by Dean Johnson would compete directly with the collegiate or general fraternity and would have to draw its membership from members of the latter. In Temple, there are no general fraternities.

As we see it, the Philadelphia situation is analagous to the situation in both New York City, with respect to Columbia University and New York University, and in Chicago with respect to the University of Chicago and Northwestern University. Knowing conditions as we do in the four above mentioned institutions, there is little doubt as to which we would select for extension purposes if we were entering these two cities anew.

The University of Pennsylvania can be compared to Columbus and Chicago University insofar as the possibilities of future development of a professional fraternity in competition with social Greek letter societies are concerned: insofar as the ultimate good our fraternity would accomplish in a "rich man's school" -typified in University of Pennsylvania, Columbia and Chicato, a comparisonin what we are accomplishing and can accomplish in a "poor man's school" as examplified in Temple, New York and Northwestern. In short, if we grant a charter to the Seneca Club, Delta Sigma Pi will be an important factor in Temple University, while the part we would play in the Wharton School of the University of Pennsylvania is questionable.
