

THE HISTORY OF

HAMMOND, LOUISIANA

LOCATION

Hammond, a very attractive city with many oak and crepe myrtle trees lining its streets, is located in Tangipahoa Parish in Southeast Louisiana, at the intersection of U. S. Highways 51 and 190, and Interstate Highway 55. Another proposed Interstate Highway is I 12. It is 42 miles from Baton Rouge, the capitol of Louisiana and 60 miles from New Orleans, the nation's second port.

Hammond is located in the heart of the famed O_Z one Belt of Southeast Louisiana. Because much of Louisiana is very humid, the Ozone Belt attracts people in search of a heathful climate and the advantages of a bracing atmosphere naturally cooled by Gulf breezes, and from which excess moisture is removed by the pine trees in the area.

GOVERNMENT

Hammond has a comission form of government with three officials elected for a term of four years -- Mayor, Commissioner of Finance and Commissioner of Streets and Parks. There are seven appointed officials and the recreation and airport commissioners. Located in the City Hall are the offices of the Mayor and Council, Water and Tax Departments, City Business Office, City Police, City Court, American Red Cross, and Veterans Affairs.

CHURCHES

There are 28 churches of 16 denominations -- Baptist, Catholic, Christian, Episcopal, Methodist, Presybterian, Seventh Day Baptist, Seventh Day Adventist, Lutheran, Assembly of God, Church of God, Church of Christ, Church of Jesus Christ of Latter Day Saints, Jehovah Witnesses, Holiness and Christian Scientist.

RECREATION

Hammond has numerous recreational facilities. There are five parks with playground equipment. Zemurray Park has a beautiful modern swimming pool and dressing rooms; a community center which is used for games, dances and meetings; two gall fields; playground equipment; picnic areas; an artifical pond which is always stocked with fish where anyone may fish except for the restocking periods. The Jaycees have a fishing rodeo for the children annually. Another park is the S. Orange St. Park on the east side of town. It has playground equipment including tennis courts, ball field, etc. There is a park in the northwest section with playgrounf equipment and wading pool. There is a playground and swim ing pool on Mooney Ave., and a lighted softball field and playground on N. Orange for the negroes. Southeastern Louisiana College and Ha mond High provide a complete athletic program.

SPORTS

For sports fans, Southeastern Louisiana College football games draw the interest of this area; also, the High School teams create much interest. Other sports are the Southeastern basketball games, Little League and Babe Ruth baseball games, Little Conference football under the sopnsorship of the Jaycees; drag races held the 4th Sunday from March through November at the Airport by the Hammond and Ponchatoula Lions Clubs. The Jaycees sponsor car races twice a year. Golf tournaments are held at the Oak Knoll Country Club.

AGRICULTURE

Hammond is the center of America's greatest Strawberry belt. Hundreds of cars of this delicious fruit are shipped to all parts of the country each spring. The farmers supplement their income from strawberries with crops of beans, peppers, cucumbers, eggplants and squash each spring and fall. Another leading industry is dairying. Large quantities of milk are shipped from local markets each year. The chicken industry is fast becoming one of the leading industries. Large flocks of chickens are becoming very predominant throughout the farm area. Within the past few years two hatcheries have built new plants. Large shipments of broilers and eggs are shipped daily through local agencies. Tangipahoa Parish has an income of more than \$17,000,000 from strawberries, milk, beef cattle, poultry and eggs and forestry, annually. The dairy and chicken industries have surpassed the strawberry in agricultural income for Tangipahoa Parish. eservation that they are as fine a group of young

COMMERCIAL

The Illinois Central Railroad divides the town east and west. The trading area includes 50 miles with a population fo 81,000. Hammond is a market center for a heavily populated farm area. The City Zone has a population of 12,728. The main commercial district is centrally located with approximately 12 blocks covered by businesses. A commercial area in the western section is building up rapidly. Though many of the buildings in the main business section were in existance at the turn of the century, the buildings have been modernized and could not be recognized as the same. In the business district, one will find all types of stores: department, ladies wearing apparel, men's wearing apparel, furniture, hardware, jewelry, drug, shoe variety, appliances, sporting goods, and many other types of businesses.





THE HISTORY OF

SOUTHEASTERN LOUISIANA COLLEGE

Southeastern Louisiana College is the outgrowth of the Hammond Junior College, which was established in 1925 by the citizens of the Southern half of Tangipahoa Parish.

The first session began on September 14, 1925, with a president, four instructors, and forty students. Both freshmen and sophomores were enrolled. Facilities of the Hammond High School were used. The main objectives of the junior college were to provide a two-year curriculum in teacher education and basic undergraduate work in the arts and sciences. The curricula were approved by the Board of Education.

The student body grew to such an extent that the high school building could no longer accommodate the college classes. In 1928 an eighteen thousand dollar bond issue was voted, and fifteen acres of the present campus were purchased for use by the College. A large residence on the property was used as a home for the president and a women's dormitory. A servants' house was remodeled to provide classrooms, laboratories, and a library. At this time the name of the institution was changed to Southeastern Louisiana College.


The work of the College continued mainly that of preparing teachers for the two-year state certificate and offering basic undergraduate courses for students who wished to enter the professional schools in the universities of the state. In 1930 a third year was added to the curricula.

The purchase of sixty acres of land adjoining the campus increased its size to seventy-five acres. During the same year one hundred thousand dollars was provided by a bond issue for new buildings. A frame gymnasium and a brick and concrete administration building were erected. The administration building provided space for offices, classrooms, and a library. It was named Lucius McGehee Hall in memory of Dr. Lucius McGhee of Hammond, one of the founders of the College, and until his death a member of the local executive committee. All science work was centered in the original frame and stucco building, which had been enlarged several times.

In 1937 the State Board of Education authorized the College to prepare curricula extending through four years and leading to the baccalaureate degrees. Four-year curricula in the liberal arts, teacher education, business administration, music and social sciences, and health and physical education were submitted to the State Board and were formally approved. The first degrees were conferred in May, 1939. The State Board in 1940 approved four-year curricula in home economics and in 1945 a four-year curriculum in agriculture.

January 18, 1946, the State Board of Education made available \$84,675.00 from emergency funds for the purchase of seven city blocks east and west of the campus fronting on Dakota Street and 275 acres of land adjoining the campus on the north and northwest, extending back to Highway 51. This increased the total area of the campus to approximately 375 acres. At the same meeting of the State Board, the reorganization of the College into the Divisionof Liberal Arts, the Division of Education, and the Division of applied Sciences was authorized.

The following presidents have served the institution since its founding: L. A. ^Sims (1925-1933); Y. L. Fontenot (1933-1937); J. Leon Clark (1937-1944); George W. Bond (acting president, 1944-1945); Gladney Jack Tinsley (1945-December 8, 1951); Luther H. Dyson (acting president, December 9, 1951-June 30, 1952); Clark L. Barrow (July 1, 1952-August 8, 1953). Luther H. Dyson has served as president since August 9, 1953. THE CAMPUS



ADMINISTRATION BUILDING

Offices in the Administration Building, completed in 1961, include those of the president, dean of the college, various academic and personnel deans, the registrar, the auditor, business manager, and special services.




TINSLEY HALL

In 1956 Tinsley Hall was completed. This building contains 14 classes and 14 offices. It houses the Busniness Administration department. Economics and history classes are also taught here. In one specially designed room there is a computer center.




LUCIUS MCGEHEE HALL

Lucius McGehee Hall a brick and steel-reinforced concrete building was erected in 1934. It was the first permanent sturcture on the SLC campus. For many years, it housed just about all the college departments, but as the institution grew the building was used mainly for administrative offices and a few classes. After completion of the Administration Building, McGehee Hall was returned to its original purpose---a class room building. Here are located both the English and health and physical education classrooms.



LINUS A. SIMS MEMORIAL LIBRARY

The Linus A. Sims memorial library is a modern, onestory, modular type, well-equipped building completed in the Spring of 1963. The building is completely airconditioned and has an excellent lighting system especially designed for library use. The building has a capacity of about 240,000 volumes and will seat about 800 people. All stacks are open.



CAFETERIA

The new cafeteria was completed in 1956. This building will accommodate 2,400 students. Movable partitions make comfortable and soundproof banquet rooms for organizations planning dinner affairs. These facilities and a new cafeteria now under construction will serve 5,000 students.



HOLLOWAY-SMITH DORMITORY

Holloway-Smith is a mens resident hall which houses about 400 men. It is for both freshmen and upper classmen. Holloway-Smith was completed in 1956.



CARTER-HARRIS DORMITORY

HISTORY OF THE

BUSINESS ADMINISTRATION DEPARTMENT

OF SOUTHEASTERN LOUISIANA COLLEGE

The Business Administration Department at Southeastern was started in 1931. At this time, the department consisted of eight home-made desks and one professor. This one professor, Dr. Garrett, is presently the head of the department at Southeastern. In 1938 the Department of Business Administration was formally established, and its academic rank recognized by the Louisiana State Board of Education. After having been shifted to various divisions during the early development of the college, it now resides in the division of Applied Sciences.

At present, there are 1,395 students and 25 highly qualified teachers. The department represents nearly 1/3 of the entire student body of 4,581 students.

Degrees are offered in any one of four different fields. These include Accounting, General Business Administration, Secretarial Administration and Marketing. Marketing had just been added in 1965.

The Business Administration Department at SLC is sensitive to our changing times and because of this is constantly progressing and raising its standards, and requirments.


At present, a data processing program is being developed. A computer was installed in January of 1965, and this computer center has proven itself an indespensible facility to the school. Computer courses are already offered; however, the immediate future will see a more complete variety of courses in this area.

Tinsley Hall houses the Business Administration Department at Southeastern. This modern, air conditioned structure was completed in April of 1956. Tinsley Hall contains modern classroom and laboratory facilities, an annex serves as office space for the professors.

Southeastern's Business Administration Department cooperates fully with the Student Government, Employment Conferences, and also with other college placement programs in order to aid in building stronger relationships between students, administrators, professors, and the entire business community.

Graduates of the department have proven successful in business and industry on both a local and national level.

Thelma Lee Bankston Associate Professor of Business Administration



Belford E. Carver Instructor in Business Administration




Charles D. Cloud Instructor in Business Administration


Oneil G. Decoteau Associate Professor of Business Administration


Ralph B. Dorman Instructor in Business Administration

Mr. Gray is also a member of the American Institute of C.P.A.'s, the Louisiana Society of C.P.A.'s, the Amite Rotary Club, and a charter member of the Amite Chamber of Commerce.




Charles E. Grenier Assistant Professor of Business Administration


Basil O. Sweatt Assistant Professor of Business Administration

The Department of Business Administration has become one of the largest departments at Southeastern Louisiana College. The forecast indicates even greater growth.


