


#### MONROE, LOUISIANA

### MONROE, LOUISIANA

Years before the Louisiana Purchase altered the course of building an American empire and unified American colonization efforts, the present site of Monroe was an established trade center on the banks of the Ouachita. In the early eighteenth century, fur traders, adventurers, and explorers used the area as a bartering ground for trade among the Indians.

Progress in the pioneer community was slow until Don Juan Filhiol, a French soldier armed with great courage, a spirit of adventure, and a land grant of 2,000 square arpents (1,680 acres) from the King of Spain, settled in the territory. Filhiol issued a proclamation placing a system of exchange and a value on commodities bartered at the trading post. Under Filhiol's administration, the first prohibition ordinance west of the Mississippi was enacted; and Fort Miro was constructed for the protection of the village. Through an act of territorial government, by 1805 Fort Miro was designated as the seat of Ouachita County.

A significant event in May, 1819 was responsible for changing the name of the small trading city from Fort Miro to Monroe. One morning the first steamboat ever to ply the Ouachita River as far north as the settlement startled residents with its tall smoking stack and shrill steam whistle. The residents were so impressed with "Monroe," the steamboat, that they renamed the town in joint honor of the boat and the President of the United States, James Monroe. Six days later John Filhiol filed an official document formally naming the community Monroe.

Monroe and West Monroe are located in the northeastern portion of Louisiana, approximately halfway between Memphis and New Orleans. The Twin Cities are on opposite banks of the Ouachita River in Ouachita Parish, which has a population of 123,000 people. The city of Monroe has a population of approximately 63,000, and West Monroe, a population of about 19,000.

National manufacturers recognize the Twin Cities as the distribution center for the rich 13-parish Northeast Louisiana market. This market consists of a spendable income in excess of one-third billion dollars. Monroe is placed in the national spotlight as the "Crossroads of Pipelines," a point where more major pipelines converge than at any other spot in the nation. Industry in the Twin City area is well balanced and diversified. Among the major industries are Olinkraft, Inc., manufacturers of Kraft paper, corrugated containers and paper bags; Commercial Solvents Corporation, methanol and ammonia; Thermatomic Carbon Company, carbon black; Selig Manufacturing Company, furniture; Buccaneer Manufacturing Company, clothing; United Gas, gas distribution, transmission production and I.T.T.--Cannon Electric Company, Electrical Components. Many other industries in the chemical, furniture, fertilizer, lumber, and paper fields are located in Ouachita Parish.

Monroe and West Monroe are the center of a large trade area of over 369,000 people. The gross sales are in excess of \$120 million annually. The Twin City area is an important distribution center for many products including hardware, lumber, groceries, agricultural equipment, building materials, paper, and fertilizer.

Louisiana ranks first in the United States in the production of early spring strawberries, sweet potatoes, and sugar cane, and second in oil and gas production. The state also ranks high in lumber production, salt, and sulphur. Availability of these important raw materials offers unlimited opportunities in this area for the manufacture and processing of chemicals, forest products, rubber, glass, ceramics, air-conditioning equipment, and numerous other products.

The Monroe Gas Fields are considered one of the major natural gas-producing areas in the country. Largediameter pipelines transport many millions of cubic feet of gas into the Monroe-West Monroe area daily, making it one of the outstanding locations for industries which use large volumes of fuel. This field covers approximately 400 square miles in Ouachita, Morehouse, and Union Parishes, with 2,813 gas wells which produce 270 million cubic feet per day.

Cultural attractions in the area include the Northeast Louisiana Community Concert Association, Strauss Playhouse, Ouachita Valley Museum, Masur Art Gallery and Museum, Civic Center and City Plaza. The Miss Louisiana Pageant, a preliminary to the Miss America Pageant, is produced each year by the Monroe Jaycees.



# HISTORY

Northeast Louisiana State College opened for its first session in September, 1931, as Ouachita Parish Junior College and was operated as part of the Ouachita Parish System.

In 1934, the College became affiliated with Louisiana State University by an act of the State Legislature and was operated as Northeast Center of Louisiana State University. The name of the College was changed again in 1939 to Northeast Junior College of Louisiana State University. In 1944, the State Legislature authorized the transfer to Louisiana State University of all lands connected with Northeast Junior College.

In 1950, the Legislature provided for the expansion of Northeast Junior College to a four-year institution and its transfer from the Louisiana State University Board of Supervisors to the State Board of Education. The name was then changed to Northeast Louisiana State College.

Since that time, the college has continued to expand in enrollment, curricula, buildings, and facilities. The faculty members are highly qualified in their fields of endeavor with an impressive number holding the doctorate.

Curricula are offered by Northeast in the Schools of Business Administration, Education, Liberal Arts, Pharmacy, and Pure and Applied Sciences. The College also offers courses in the following pre-professional classifications: Pre-dentistry, Pre-engineering, Pre-forestry, Pre-law, Premedicine, Pre-social Work, Pre-veterinary Medicine, and Pre-vocational Agricultural Education.

The graduate school, established in 1961, offers master's degrees in art, biology, business administration, chemistry, education (administration and supervision, elementary education, guidance, secondary education), English, geology, health and physical education, history, mathematics, music, pharmacy (hospital pharmacy, pharmaceutics, pharmaceutical chemistry, pharmacology, pharmacy administration), physics, social sciences, and speech. In the fall of 1967, the Graduate School was authorized to add the education specialist degree with majors in administration and supervision, elementary education, guidance and secondary education.

The College is a member in good standing of the Southern Association of Colleges and Schools and the National Association of Schools of Music. The School of Pharmacy is accredited by The American Council on Pharmaceutical Education. The teacher-preparation programs at the bachelor's and master's degree levels are accredited by the National Council for Accreditation of Teacher Education. The Department of Nursing is accredited by the National League for Nursing. The Home Economics Department is accredited as a Vocational Teacher Training Department.

The College also holds membership in the following professional but non-accrediting agencies: American Association of Colleges for Teacher Education, American Association of Colleges of Pharmacy, American Council on Education, Association of American Colleges, and National Commission on Accrediting.

The American Association of University Women, of which the College is a corporate member, admits women graduates of Northeast Louisiana State College to national membership.

The Reserve Officers Training Corps at Northeast includes a four-year program designed to provide systematic general military training to qualify selected students as officers in a component of the U. S. Army.

The fundamental educational aim of the ROTC program is to make the student, as a citizen, conscious of his duties and responsibilities to his government and to prepare him to fulfill his responsibility in accordance with his training and capabilities in time of national emergency. Those ROTC graduates who do not follow a military career will benefit as future business and professional leaders through their superior preparation for positions of responsibility.

In keeping with the College's philosophy of encouraging students in their personal development, it is felt that each student should assume responsibility in meeting College requirements. Students are graded on a four point system with the grades A (excellent), B (good), C (average), D (below average), and F (failure) given to indicate the quality of a student's work.

An honor roll is released at the end of each semester. To qualify for this roll, a student must carry at least twelve hours of work and must earn at least a B average.

Any full-time or part-time student who makes an average from 1.0 to 1.5 on all hours pursued during a semester will be placed on probation. A student who resigns after mid-semester will be placed on probation if his average at the time of his resignation is between 1.0 and 1.5. To be removed from probation, the student must make a C average (2.0) on all hours pursued during the next regular semester of enrollment.

Courses of study leading to baccalaureate degrees are administered under the School of Business Administration, Education, Liberal Arts, Pharmacy, and Pure and Applied Sciences.

The Bachelor of Arts degree is conferred upon students who major in art, art education, elementary education, English, English education, foreign language education, French, geography, government, history, journalism, music, pre-law, pre-social work, psychology, radio and television management, social studies education, sociology, Spanish, speech, and speech education.

The Bachelor of Business Administration degree is conferred upon students who major in the area of accounting, business administration, economics, marketing, and office administration.

The Bachelor of Music degree is conferred upon students who major in the areas of applied music, history, and literature of music, and theory and composition of music.

The Bachelor of Music Education degree is conferred upon students who major in the area of music education.

The Bachelor of Science degree is conferred upon students who major in the area of agriculture, agriculturebusiness, agronomy, animal science, aviation, biology, biology education, building construction, business education, business and office education, chemistry, chemistry education, computer science, distributive education, geology, geophysics, health and physical education, home economics, home economics education, mathematics, mathematics education, pre-dentistry, and pre-medicine. The Masters of Art, Master of Business Administration, Master of Education, Master of Music, Master of Music Education, and Master of Science are awarded in the Graduate School, which is under the general supervison of the Graduate Council.

The Education Specialist degree is awarded with major areas of concentration in administration and supervision, elementary education, guidance, and secondary education. This advanced degree requires at least two years of graduate study beyond the bachelor's degree or one year beyond the master's degree.

Courses taken at other accredited institutions are accepted if they apply toward the curriculum the student selects at Northeast, and if grades are satisfactory.

Campus housing is offered to all students, and is under the supervision of the Dean of Men and the Dean of Women. All resident halls are air-conditioned. Residences for men are Hudson Hall, Madison Hall, Masur Hall, Sherrouse Hall, and Olin Hall.

Residences for women are Breard Hall, Cosper Hall, Harris Hall, Lemert Hall, Monroe Hall, Nicholson Hall, Ouachita Hall, and Slater Hall.

The college also provides infirmary service with limited medical and nursing care for mildly ill students. A college physician is also available for emergencies.

The philosophy of the student personnel program is that each student must be considered a distinct personality with his own individual characteristics. Such a philosophy stresses the necessity of working individually with each student in terms of his particular needs, whether they be academic, social-personal or physical. These needs are met, as far as possible, with the existing facilities and trained personnel on the College campus.

Student social needs are met through various College sponsored organizations such as scholastic honor societies, departmental and pre-professional societies, service clubs, special interest groups and social organizations for both men and women.

Northeast Louisiana State College is presently the third largest state supported college under the Louisiana State Board of Education with an enrollment of 7,602 students for the fall semester, 1968. In the enrollment, which is nearly 900 over last fall's mark, are students representing 39 states as well as 19 foreign countries. Such rapid growth is expected to continue for Northeast in coming years.

During the past ten years, four academic buildings, ten dormitories, and three dining facilities have been constructed, in addition to the construction and renovation of various other facilities on the Campus. Construction of the new Administration-Classroom Building is underway, and we expect to have occupancy of this building in September, 1969. Administrative offices will be on the first floor and the School of Business Administration will be on the second and third floors. The new Health and Physical Education Building-Assembly Hall across the bayou and Brown Hall renovation and additions are now underway. Final plans are now being completed for the new Pharmacy Building, and we anticipate that the \$2,000,000 facility will be occupied in 1970.

We are proud of these achievements, and it is the constant aspiration of the faculty and staff to make Northeast an institution of higher learning of special merit.

#### NORTHEAST LOUISIANA STATE COLLEGE

Northeast Louisiana State College campus is one of the state's most attractive campuses. Picturesque Bayou DeSiard flows through the tree shaded site in the eastern part of the City of Monroe.

#### FUTURE ADMINISTRATION BUILDING

Today's complex world of business--destined to become even more complex tomorrow--offers unequaled opportunities to those who have the training and background for a highly demanding but fascinating career.

To keep up with this expanding progress, Northeast Louisiana State College is presently constructing a new complex which will house the college administration and the Business Administration offices. The building will be a three-story complex and is planned to be the center of all college activity.

The School of Business Administration at Northeast has faculty members who are qualified and eager to develop qualified business leaders. The programs and facilities at NLSC are regularly revised and updated so that the most modern approach can be offered.




#### SANDEL LIBRARY

More than 115,000 volumes are housed in Northeast Sandel Library, including 3,000 volumes on microfilm or microcard. The modern, air-conditioned structure is centrally located on campus and facilitates the entire learning process.

More than 850 persons can use the Library facilities at one time. Students may choose books from open shelves, or read one of the more than 1,000 magazines, journals, and newspapers housed in the periodicals section.


The Library also includes photo-copying equipment, an audio-visual room, microfilm reading equipment, public typing rooms, and a rare books collection.



#### FUTURE ASSEMBLY BUILDING

Brown Gym is being evacuated, and Northeast's new "Dome" Basketball Gym and Assembly Building is presently being constructed. The Building will be located adjacent to Olin Hall, across from Bayou DeSiard.

The building is one of the most modern in the state and is planned to be completed by fall, 1969.




#### COLLEGE UNION BUILDING

Social life at Northeast Louisiana State College is stimulated through use of its highly modern College Union Building. Students gather at the CUB between classes and discuss current activities over a coke or cup of coffee.

The College Union also houses bowling lanes, pool tables, barber and beauty shops, an auditorium for movies, commuter lounges, stereo and television rooms, conference rooms, the post office, the bookstore, and a snack bar.

#### OLIN HALL

Olin Hall is Northeast's most current housing facility. It rises eleven stories high and is Northeast's first "hi rise" dormitory. Besides having color television lounges on every floor, the dorm houses a capacity of 832 male students.

All residence halls on campus are air-conditioned; most of the halls have two-room suites with a connecting bath. Students may either occupy a single room or share a room with another student. Single rooms are available in all residence halls. Spacious lounge areas, snack kitchens, self-service laundries, hairdryers, "piped-in" music, intercom systems, private telephones, and other features make on-campus living a delightful experience.

A varied program of activities is provided for students who live on campus. Residence hall councils direct such events as house parties, open houses, Christmas and Homecoming decorating contests, and Mothers' Weekend.



#### SCHOOL OF EDUCATION

Emphasis on the preparation of prospective teachers who are versed in both their specialized teaching fields and in professional methods forms the basis for study within the School of Education at Northeast. Students receive foundation work which prepares them to be proficient in the myriad techniques employed in guiding their pupils, and they also gain insight into the moral and esthetic obligations inherent in the school and community.

Five departments are included within the School of Education. These are the departments of Elementary and Secondary Education, Health and Physical Education, Music, Psychology, and the Special Education Center.



#### SCHOOL OF LIBERAL ARTS

It is becoming more evident that we must do more to instill human values that prepare mankind to live together in a dynamic society. The disciplines offered the student of liberal arts lead to a higher awareness and deeper understanding of the responsibilities demanded of him in the complex of cultures. The School of Liberal Arts provides an academic environment designed to stimulate creative thought and responsible living.

The School of Liberal Arts at Northeast offers work in five departments--Arts, Languages, Military (U.S. Army Reserve Officers Training Corps), Social Sciences, and Speech. The School offers courses in the humanities and social sciences as a foundation for a broad cultural education, as preparation for later admission to professional schools or for research, college teaching, or professional careers in the several subject-matter fields.




#### SCHOOL OF PHARMACY

A modern three-story complex is presently under construction which will house Northeast School of Pharmacy.

Graduates of Northeast State's School of Pharmacy are prepared for one of several careers within the area, depending on the individual student's aptitude and interest. Within the school, students train to be retail pharmacists, professional or industrial drug representatives, or pharmacists in government service.

Still others may pursue the school's graduate program for careers as college teachers, as research or management personnel, for firms maufacturing pharmaceuticals, or as government or university scientists.


The five-year course leads to the degree of Bachelor of Science in Pharmacy. The two-year pre-pharmacy program is followed by a three-year professional pharmacy curriculum.



#### SCHOOL OF PURE AND APPLIED SCIENCES


Nine departments are included in NLSC's School of Pure and Applied Sciences. These are Agriculture, Biology, Building Construction, Chemistry, Geology, Home Economics, Mathematics, Nursing, and Physics.

One significant feature of the department is its research museums and herbaria with outstanding collections of animals and plants. The fish and reptile collections are among the leading research collections in the nation. Field courses are balanced with laboratory and theory courses. A major objective of the department is to train students for graduate work.



#### ATHLETICS

Sports at Northeast State are designed for both the participant and the spectator. The College is a member of the Gulf States Conference, National Association of Intercollegiate Athletics, and the National Collegiate Athletic Association and fields intercollegiate teams in baseball, basketball, cross country, football, golf, gymnastics, tennis, and track.





Northeast Louisiana State College is the home of pretty girls, Each year the Miss Northeast Pageant is produced by the Student Government Association. The purpose of the pageant is to choose a girl to represent the College throughout the year and to participate in the Miss Louisiana Pageant. One girl is nominated by each organization on campus and twelve of these contestants are chosen as finalists in the spring production. There have been five Northeast coeds to be named as Miss Louisiana in the past six years.

### BUSINESS ADMINISTRATION

# HISTORY

On July 26, 1950, Northeast became a four-year senior college and was renamed Northeast Louisiana State College. At this time, the Business Administration Department was formed.

The major purpose of the School of Business Administration is to educate students for positions of responsibility in private and public business and professions and to enable them to advance rapidly both in their positions and also in the appreciation of the values and obligations of citizenship. To achieve this purpose, the School gives its students thorough grounding in the fundamentals of business, offers each one specialized instruction in the professional field of his choice, requires a planned and coordinated non-business program designed to increase cultural appreciation and give a broad knowledge of world affairs, and emphasizes the psychology of dealing with persons in all walks of life.

The curricula allow for differences in the interests, abilities, and aspirations of students. Each curriculum provides for a general understanding of our economic system and modern business environment and also strives to make students aware of the forces working to shape the economy and business enterprise of the future.

Specific objectives of the School of Business Administration include the following:

- To prepare students for careers in accounting, economics, finance, marketing, office administration, industrial management, and business education.
- To prepare students for roles as business and civic leaders.
- 3. To foster and encourage research in the areas of business and economics.
- 4. To render service to the business community.

5. To prepare students for graduate work.

Specialized courses in the Business Administration Department have been grouped into divisions so that the student may (a) develop skill in the use of business techniques, (b) acquire the capacity to apply knowledge of business practices and procedures in reaching sound decisions on business problems, and (c) acquire professional training in some areas of business. Throughout the curricula emphasis is placed upon the social responsibilities which rest upon the modern businessman and upon his need for adopting and using ethical business practices.

Students majoring in Business Administration select an option from among those explained below. The courses listed for the option are to be taken in the Junior and Senior years.

The Business Data Processing option is selected by students who desire special strength in data processing concepts and tools, combined with a broad program of selected courses in Business Administration. Students acquire operational ability in data processing and a knowledge of how data processing aids in reaching managerial decisions.

The Finance option is designed to prepare students for careers in business finance, commercial banking, investment banking, securities brokerage, trust management, and property management. It also provides training for careers with governmental agencies engaged in lending operations and regulation of securities markets.

The Industrial Management option prepares students for careers as managers in manufacturing firms. The program combines technical courses in chemistry, engineering, and physics with selected Management and other business administration courses.

The Insurance option is designed for students preparing to enter the private or public insurance field. It offers the student a broad study of subjects related to life insurance, property and casualty insurance, and health and social insurance.

The Management option is taken by students who aspire to responsible managerial positions in business firms or other organizations. The program provides for development of abilities needed for a first position, and presents the broad theoretical background required for higher managerial responsibilities. The General Business option provides the student with a broad education and basic training in business administration. In addition to the basic requirements for a major (Business Administration), the General Business option requires six or more hours of Junior-Senior level courses not otherwise required in at least three of the following concentrations: Accounting, Business, Economics, Finance, Management, Marketing, or Office Administration.

The School of Business at Northeast has undergone rapid growth from its inception. In the ten years between 1958 to the present, Northeast's School of Business has experienced over a 300% increase in enrollment; from 452 students in 1958 to 1,846 at the present. Forecasted enrollment for the year 1970 indicates an expected enrollment of 2,500 students in the School of Business.

Northeast is proud of its 50 dedicated faculty members. According to Dean Vines, Northeast ranks in the top 20% of the best Business Schools in the nation; with 54% of its Business faculty holding terminal degrees, and ten others are working on their doctoral dissertations.


