### HISTORY OF SOUTHERN ILLINOIS UNIVERSITY

Southern Illinois University is a multi-purpose and diversified University that, since its establishment in 1869, has sought to meet the educational needs of the times for the people which it serves as a public institution. It is fully accredited by the North Central Association of Colleges and Secondary Schools.

Though the student population has increased manifold from its beginning, the formation of schools, colleges, divisions, and departments within the University enables the institution to concentrate on the special interests of its individual students. The University in total size now ranks twentieth in the nation. It offers facilities and faculty to give general and professional training to students ranging from two-year programs leading to associate degrees to the doctoral degree level.

Southern Illinois University, with major campuses at Carbondale and Edwardsville, Illinois, is one of the nation's largest Universities in terms of full-time students. The University's student body represents all counties of Illinois, several states and 70 foreign countries. The University is accredited by the North Central Association of Colleges and Secondary Schools, and has faculty or institutional member-

ship in more than 530 additional associations of a professional nature in higher education.

Because of the growing demand for educational opportunities in the Madison-St. Clair county area, the University established the Alton Residence Center and the East St. Louis Residence Center in 1957, the former on the campus of what used to be Shurtleff College, the latter in a senior high school building.

During the year 1958-59, communities in Madison and St. Clair counties launched a drive that helped acquire a large central campus site on the outskirts of Edwardsville, Illinois, approximately twenty miles east of St. Louis, Missouri. From what was once farm land has now risen a complex of uniquely designed buildings which constitute the Edwardsville campus.

The Edwardsville campus had its beginning in 1949 when the Belleville Residence Center was established. Because of the growing demand for opportunities in higher education in the Madison-St. Clair county area, the University established the Alton and East St. Louis Centers in 1957. In November of 1957, consultants were appointed to investigate possible sites in the Madison-St. Clair county area for a new campus to be constructed. In March, 1958, the Board of Trustees of Southern Illinois University selected 2600 acres of rolling farm land and wooded valleys along the bluffs flanking the Mississippi River southwest of Edwardsville as the new campus site. Funds contributed by 60,000 area citi-

zens made possible the initial purchase of the desired acreage.

The master plan for the Edwardsville site provided facilities for adaily commuting student body of 18,000. Buildings now occupied in the first phase are Lovejoy Library, Peck Classroom Building, Communications Building, Science Laboratory Building, and the University Center. In the planning or construction stages are buildings for administration, physical education, theatre and fine arts, as well as an office wing on the Science Laboratory Building.

The total number of students presently enrolled at the Edwardsville campus is 10,337; out of this total number the business students number 758.

The University Center houses the faculty offices of the Business Division, on the second floor. The Center also houses the Cafeteria, Book Store, and the recreation area for students.



The Peck building is where most of SIU's business classes are held. The building contains experimental class-rooms with an elevated "U shaped" desk design. These class-rooms promote closer relationships between student and instructor.



### HISTORY OF THE BUSINESS DIVISION

The academic program of the Business Division Southern Illinois University, Edwardsville Campus is designed in anticipation of the needs of students who will graduate in the early 1970's and whose business careers may well extend beyond the year 2000. The Business Division feels that knowledge is pouring in so fast that the student must be taught in college to learn easily rather than just receive training in one particular field.

The Business Division was started in 1965, the same year the Edwardsville Campus was opened. At this time the faculty consisted of 40 members including Dr. John Glynn, the first dean of the Business Division. Bachelor of Science Degrees were offered in Economics, Marketing, Management and Accounting; with 410 undergraduates majoring in these fields.

Since 1965 the Business Division has become larger every year, making its facilities better and better. In the 1966-1967 school year Dr. Kenneth Meyers became dean of the Division bringing new and better ideas. An increase in the number of undergraduates majoring in business to 530 made it necessary to increase the faculty to 45.

In the 1967-1968 school year the faculty was increased to 51 members in order to keep up with the ever increasing

number of students majoring in business, 648 in the fall quarter. Beginning the fall quarter Dean Meyers initiated a new program for the Business Division. This new program consisted of dividing the Business Division into three broad areas with different degree programs for each. These three areas are Business Administration, Economics and Business Education.

Students who are interested in business administration work toward a Bachelor of Science degree with a concentration in Business Administration. All students take the same general business courses supplemented by a sequence in one of the following specializations: General Accounting, Professional Accounting, General Business Administration, Economics, Finance, Personnel and Industrial Relations, Management Science and Marketing. There are two somewhat different degree programs in Economics offered by the Business Division: the Bachelor of Science degree with a concentration in Economics. A Bachelor of Science degree is offered by the Business Division; this is supplemented by a concentration in Secretarial and Office Administration.

The Fall Quarter of 1968 found another increase in faculty to 61 in order to instruct the 758 business majors. The Fall of 1968 also found new academic programs in the Business Division. One of these is the Professional Experience Program (PEP). This is a co-op, work study program in which

students work for an area company for six months a year in order to learn some of the practical aspects of business. Another program is called Learning through Integrated Faculty-Student Teamwork (LIFT). This program utilizes block scheduling of the first year core courses, making students available from 8:00 a.m. until 2:30 p.m. four days per week. These are only two examples of programs which have already been launched. The Business Division, always looking forward, is preparing other programs of an innovative nature to be put into use.

The new Business Division offices are located on the second floor of the University Center. Dividers and plants give a feeling of privacy when a person is seated, and openness when standing.





DEAN KENNETH H. MYERS

Dean Kenneth H. Myers was born in Sioux City, Iowa. He is married and the father of three children. Dean Myers earned his Bachelor's and Master's degrees from Harvard University and his Doctor's degree from Northwestern University in the fields of Economics, Marketing, Industrial Management, and Finance. He has been a professor at Northwestern University, University of Southern California and Dean of the Business Division at Southern Illinois University. His professional society memberships are: Academy of Management, American Economic Association, Business History Association, Economic History Association, and The Institute of Management Sciences.

#### HISTORY OF CHAPTER

Ron Vassel, Mike Klaus and Don Clevenger, three business students at Southern Illinois University first discovered the need of a fraternity to aid the development of brotherhood among business students. The SIU campus was less than five years old and was rapidly expanding. The need for a professional business fraternity was evident.

In May of 1968, an organizational meeting was held and Delta Sigma Psi became a reality. The charter members checked into several professional business fraternities and decided to become affiliated with Delta Sigma Pi. On May 23, the first professional meeting was held at the Flaming Pit Restaurant with Dr. Sokolik as the guest speaker. The rest of the spring quarter consisted of organizing the chapter into an efficient operating group.

The fall quarter began with a dinner meeting with Ben H. Wolfenburger, Executive Secretary, to discuss our plans to pledge to Delta Sigma Pi. Committees were formed to start preparing for the pledge period. Our first pledge program was formed this quarter with 15 interested pledges. The pledge period lasted twelve weeks in which twelve pledges were accepted as members of Delta Sigma Psi. The rest of the quarter was devoted to promoting Delta Sigma Psi's name on campus and to building a stronger program for the members.




