We, the Delta Sigma Fraternity in The School of Business and Administrative Sciences at California State University, Fresno, voted unanimously on January 30, 1980, to seek a charter in The International Fraternity of Delta Sigma Pi.

Our organizational meeting took place on January 30 in the Business Building at CSUF. Conducting the meeting was Past Grand President Bill Tatum, accompanied by Dr. Kelly Black (Fraternity Advisor) from Epsilon Theta Chapter, Dr. Paul Lange, Zeta Chapter, Dr. Gerald Johnston, Gamma Omega Chapter, and Hays Englehart and Gerry Hubbell of Epsilon Phi Chapter. Seven student members were recruited by the above faculty members to form a nucleus for our organization. The national slide presentation was utilized.

We immediately began recruiting additional members by setting up a recruiting table and through the display of posters throughout the Business Building. We currently have forty active members. Delta Sigma Fraternity has met weekly since our beginning at 7 p.m. Wednesday night in Room 200 of the Cafeteria.

Our first social function was held on Saturday, February 2, for the purpose of getting to know each other. The function was a pizza feed following a short business meeting. Our social was very successful with thirty-five of our members attending. Faculty participation was very good also.

Our second business meeting was held on February 6 during which we elected officers and conducted a planning session. Plans begun immediately for our professional program, fund raising activities, and community service projects. The president appointed committees for each of the specific projects and nominated committee chairmen to begin planning.

Our first professional activity was held on February 20 at 7:00 p.m.. Our guest speaker for the evening was Mr. Larry Wages who serves as General Manager and secretary of the Merchants Association of Fresno.

THE HISTORY OF THE DELTA SIGMA COLONY

The history of our colony dates back to March of 1979, when Hays Englehart was visiting the Epsilon Phi Chapter located at California State University, Sacramento. As an alumni of their chapter, Hays discussed with its members the possibility of starting a chapter of Delta Sigma Pi on the campus of California State University, Fresno. The members of Epsilon Phi were extremely excited with Hays' proposal and took the first step toward its realization by contacting Past Grand President Bill Tatum for assistance.

Bill Tatum welcomed the challenge and in the months that followed, contacted the Dean of the School of Business at CSU, Fresno as well as alumni who were faculty at the University. In November of 1979, a meeting was held at which time Bill Tatum discussed with the Dean and faculty alumni, the future of Delta Sigma Pi on their campus. In attendance of this meeting were Dr. Gene Burton, Dean of the School of Business, Dr. Kelly Black, Epsilon Theta, Dr. Paul Lange, Zeta Chapter, Dr. Gerald Johnston, Gamma Omega and Hays Englehart. With the approval of the Dean, the faculty members decided to proceed with colonization and established their first priority as selecting a small group of students who were each outstanding achievers and leaders of the School of Business.

When the selection process was complete and each of the students had been personally contacted, an organizational meeting was scheduled. The meeting took place on January 30, 1980. During this meeting, Past Grand President Bill Tatum

discussed with the seven selected students the nature of Delta Sigma Pi and the steps necessary to become a chapter. He also utilized the national slide presentation to illustrate the history and operations of Delta Sigma Pi.

During the next few days, we began recruiting additional members and elected officers. The President appointed committees to begin planning our professional program, fund raising activities and community service projects. By the end of February, we had already held our first professional activity, scheduled various fund raising and community service projects and were holding regularly scheduled business meetings each week. We now had over thirty active members.

As of this date, we have held a car wash and a bake sale as fund raising activities which collectively brought us over \$200.00. We have continued in our professional program and have a community service project scheduled to take place in a few days. From a small group of seven students, we have grown to over forty active CSU, Fresno Business students.

We are all very excited about the possibility of becoming a chapter of Delta Sigma Pi and are striving to conduct our meetings and activities according to those of a chapter of Delta Sigma Pi.

We, the Delta Sigma Pi Fraternity in The School of Business and Administrative Sciences at California State University, Fresno, had our first meeting on January 30, 1980. Our organizational meeting took place in the Business Building at CSU, Fresno. Conducting the meeting was Past Grand National President Bill Tatum, accompanied by Dr. Kelly Black, Faculty Advisor, from the Epsilon Theta Chapter, Dr. Gerald Johnston from the Gamma Omega Chapter, Hays Englehart and Gerry Hubbell of Epsilon Phi Chapter. Seven students were recruited by the above faculty to form the nucleus for our organization. The national slide show was presented and Bill Tatum started the enthusiasm rolling.

We immediately began recruiting additional members by setting up a recruiting table and through the display of posters throughout the Business Building. At this time we began meeting every Wednesday night at 7:00 pm in Cafeteria 200.

Our first social function was held on Saturday, February 2, 1980 for the purpose of getting to know each other. The function was a pizza and beer party at Shakeys Pizza. It was very successful, everyone had a good time and 35 members attended.

Our second business meeting was held on February 6, during which we elected officers and conducted a planning session. Plans began immediately for our professional program, fund raising activities and community service programs. The President appointed committees for each of the specific projects and nominated committee chairmen to begin planning.

Our first professional activity was held on February 20 at 7:00 pm in Cafeteria 200. Our guest speaker for the evening was Mr. Larry Wages who serves as General Manager of the Fresno Merchants Association.

Business meetings were conducted on February 27 and March 5 at their usual time. In addition to these business meetings, the Executive Council, headed by President Nicki DiLiddo met weekly on Monday mornings at 6:30 am at Denney's Restaurant. At 1 pm, a picnic was held at the park....Everyone had a great time eating, relaxing, enjoying the sun and playing softball.

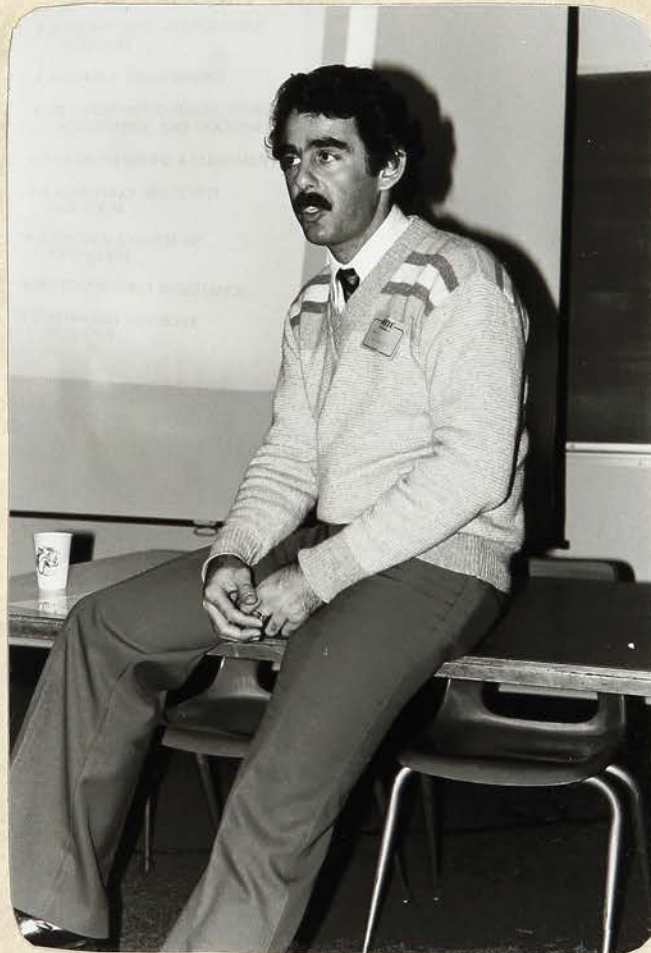

THE HISTORY OF
CALIFORNIA STATE UNIVERSITY, FRESNO

The University is located at Cedar and Shaw Avenues in the northeast section of the City of Fresno. It is the sixth oldest in the California State University and Colleges system. It began with the establishment of the first junior college in California in 1910 and a state normal school in 1911. In 1921 the combined schools became Fresno State Teachers College, authorized to offer a four-year program and grant the Bachelor of Arts degree in teaching. In 1935, by act of the Legislature, the official designation became Fresno State College. A variety of degree programs in addition to those related to the teaching credential were authorized at that time. The first Masters degree was offered in 1949. Today it is offered in 37 fields of study. The options offered in the School of Business for degree are: Accounting, Agribusiness, Business Economics, Computer Applications & Systems, Finance, General Administration, Health Care Management, Insurance, Legal Environment of Business, Marketing, Office Administration, Personnel & Industrial Relations, Quantitative Analysis, Real Estate & Urban Land Economics, and Transportation & Physical Distribution Management.

Fresno State College (now California State University, Fresno) in 1911 had an enrollment of 150 students, most of whom were women. By 1940 the enrollment had increased to 2,000 students, by 1964 to 7,000. In the spring of 1980, 14,316 students were registered, with 2,631 being in the School of Business.

HISTORY OF THE SCHOOL OF BUSINESS
CALIFORNIA STATE UNIVERSITY, FRESNO

Education for business at CSU, Fresno dates from 1926, when the first courses were given in the Social Science Department. A year later, the Commerce Department was organized and, in 1928, Fresno State Teachers College was authorized to confer a Bachelor of Arts degree in Commerce with a special secondary school teaching credential. In 1936, the State Legislature recognized a de facto situation by changing the function of the College from teacher education to that of a four-year liberal arts college, and deleting "Teachers" from the name.

The name of the Department was changed to Business in 1949 and, in 1951, the Department became the Division of Business, one of twelve instructional divisions in the College. The Division of Business was admitted to membership in the American Association of Collegiate Schools of Business in 1959. During the 1964-65 academic year, the name was changed to the School of Business.

Graduate courses, with no degree, were first authorized in 1945. The Master of Arts degree in Business was approved in 1951, and the authority to grant the Master of Science degree was received in 1957. The Master of Business Administration program was approved by the California State College Trustees in 1963.

OUR CAMPUS

California State University, Fresno is a diverse, multi-service institution serving more than 15,000 on-campus students. The students come from 37 states and 63 foreign countries. Now offering more than 2,000 courses through its 10 schools, there are 92 undergraduate and 37 master degrees offered. Fully accredited, CSU, Fresno has the second highest number of nationally accredited departmental and professional programs among the 19 campuses of the California State University and Colleges system.

In a setting of colorful trees, shrubbery, flowers, and lawns, the main campus of 220 acres has more than 45 buildings. CSU, Fresno is an official Arboretum; there are more than 4,000 trees representing 85 different species. An additional 34 structures are on the 1,190 acre University Farm, which is considered one of the most modern and best equipped agricultural plants in the west.

Beginning as the first junior college in California and now the sixth oldest in the State University system, CSUF continues to grow. A \$9,000,000 Science Building is the newest structure on campus. Scheduled for completion in 1980 are the new \$6,234,000 stadium which will seat 30,000 fans and a \$5,250,000 addition of 90,000 square feet to the library.

A tree-lined amphitheater accommodates commencements, convocation, and other large assemblages and provides an outdoor setting for numerous programs and gatherings during the year. A centrally located memorial court, benches, and fountain are favorite spots for relaxation. The adjacent free speech

area and college union are centers of student life and activity.

A Center for Information Processing is available to serve all information processing and computation needs of the university. The laboratories provide timesharing terminals, keypunches, sorters, and consultants are available in the Instructional Laboratories to give assistance in the use of facilities and computer programming.



OUR LIBRARY

Open 83 hours a week, the library is housed in a building completed in 1965. A new addition of 90,000 square feet is due to be completed in 1980. It's resources include 575,000 cataloged volumes, 220,000 government publications, 23,000 pamphlets, 80,000 maps, 26,000 pictures and prints, and over 3,700 periodicals that are received on subscription. The music library has over 40,000 phonodiscs and tapes. Professional librarians are available to assist students in their use of library materials.

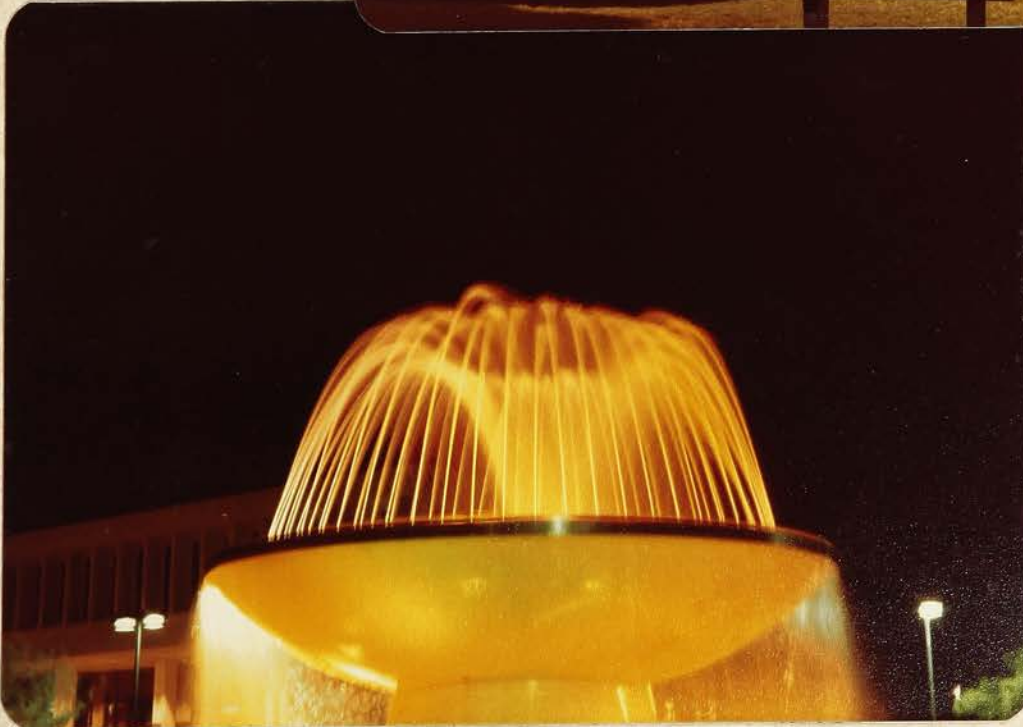

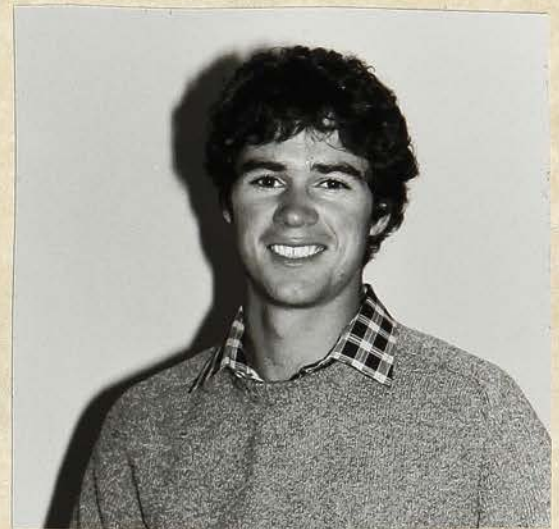

Mark is a resident of Porterville, Calif. He is a Junior this year majoring in Legal Environment of Business. He is 21 years old.



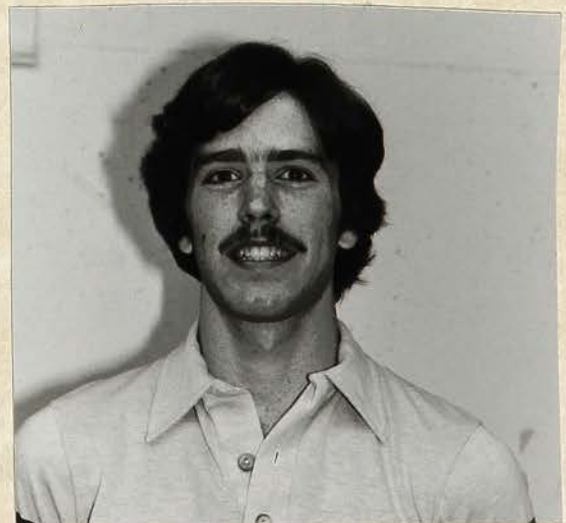

We request your consideration of Delta Sigma Fraternity as the next chapter of Delta Sigma Pi.




Dear Sirs,
