HISTORY OF KENNESAW, GEORGIA

Behind the Kennesaw City Hall, there is a lovely shaded spot that centers on a bubbling spring. The Cherokee Indians called it "Equa Ganugo Gr Ama," that translates to "The Big Spring of Water." As long as memory could recall, the location on the borders of the Creek and Cherokee Indian nations had been a meeting place for the tribes. The cold, clear water provided a welcome respite to all who came to the reliable spring. The presence of the spring figured prominently in the history and development of this area.

Early in 1839 at this location, just seven miles north of Marietta, Georgia, a haphazard construction camp was built to shelter and feed a portion of the almost 500 workers converging on Cobb County to take part in the railroad building craze sweeping the nation. Known then as the "Big Shanty", this collection of shanties was the beginning of what is now the City of Kennesaw. Since the time of its inception, this area has played an important part in the history of our country.

This railroad stop shared in the stirring moments of railroad's most dramatic period of history — 1850-1870 — when the development of the railroad provided a link of communication from one end of the country to the other.

In June 1861, as tension mounted between the North and the South, Governor Joe Brown of Georgia established Camp McDonald at Big Shanty for the training of The Georgia Militia. Once again the choice of this location was due to the presence of the spring. Less than a year later on April 12, 1862, one of the most novel episodes of the "War Between the States" began in Big Shanty. Known as "The Great Locomotive Chase", or "Andrew's Raid", this unique event has been chronicled in newspapers, magazines, books and two major movies.

A group of twenty Union spies, led by civilian James Andrews, hijacked a Confederate locomotive named "The General" and steamed north towards Chattanooga, attempting to disrupt the Confederate supply and communications lifelines. Pursued by conductor William Fuller and Anthony Murphy for 87 miles and eight hours, the raid failed in its objectives. But the daring exploit and subsequent chase have become part of our nation's collective consciousness. One hundred years later, the battle between Georgia and Tennessee over ownership of "The General" generated almost as much national

attention as the original raid did. "The General" is permanently enshrined in the Big Shanty Museum in Kennesaw in 1972.

Two years later, when the Civil War was at its peak, the area around Big Shanty played a prominent role. General Sherman, with 100,000 Union troops and 254 pieces of artillery, marched from Chattanooga to Atlanta. General Johnston, with 65,000 Confederates and 187 cannons was sent to stop Sherman. Sherman continually forced the Confederates back by attacking on the sides and forcing Johnston to retreat and re-entrench. On June 19, 1864, Sherman's troops had forced Johnston to withdraw again, this time to a prepared defensive position anchored by Kennesaw Mountain, a lofty humped ridge with rocky slopes rising above the surrounding plain. The Confederates were able to hold the mountain for nearly two weeks, when Sherman used diversion strategy and flanked the side of the mountain nearest the Chattahoochee River. Eventually, Sherman pushed on and the famed "Burning of Atlanta" occurred on August 31, 1864. During the Battle of Kennesaw Mountain, the Northerners lost 3,000 men and the Confederates 800.

Kennesaw was not finished being in the spotlight, however. On May 1, 1982, Kennesaw rocked the world by passing its now famous "Gun Ordinance." The ordinance, which requires all households to own a gun and ammunition, caused an international sensation that has not yet abated. The law was the brainchild of then Major Darvin Purdy and then Police Chief Robert Ruble. Since the passage of the law, the crime rate has dropped significantly from 11 burglaries per 1,000 to 2.7 burglaries per 1,000 in 1992.

Today, Kennesaw is the center of a thriving, vibrant community and is the fastest growing municipality within Cobb County. The population continues to grow, as it has nearly doubled since 1984. International corporations such as Athlete's Foot and UPS have moved their headquarters to Kennesaw. And in the midst of it all Kennesaw State College continues to draw students and businesses with its ever expanding programs.

HISTORY OF KENNESAW STATE COLLEGE

When the Board of Regents of the University System of Georgia voted on October 9, 1963, to locate a junior college in Cobb County, the land that would eventually become the campus of Kennesaw State College was nothing more than woods, plowed fields and rolling pastures.

J. Steve Frey, a grocer for 20 years on the Marietta Square, had farmed these isolated acres since 1946. But by the 1960s, agriculture was a dying industry in Cobb County. The wealth of jobs available at Lockheed Aeronautical Systems had eroded the supply of cheap farm labor and caused a population boom. Cobb County was rapidly being transformed into an affluent, suburban community. The Freys knew the time had come to sell their farm and the governments of Marietta and Cobb County purchased 152 acres of it for \$100,000 to give to the Regents in 1964.

While bulldozers went to work clearing the land, the Regents recruited Dr. Horace W. Sturgis, a former physics professor who had most recently served as associate registrar at Georgia Institute of Technology to become president of the new junior college.

The institution did not yet have a name when Dr. Sturgis took office on July 1, 1965. He assumed that, like many other colleges, it would take its name from the most prominent nearby community. However, his early reference in his correspondence to Marietta College brought howls of protest from those who had different ideas. Fortunately, Dr. Sturgis was willing to reconsider. He did not like the name Cobb Junior College and thought Kennesaw Mountain Junior College was too wordy, but the name recognition of the famous Civil War battle site appealed to him and, after meeting with local public officials and community leaders, he recommended that the Regents name the institution Kennesaw Junior College.

The college was schedule to open in the fall of 1966, but a series of labor disputed plagued construction of its buildings and parking lots. As summer gave way to fall, it became apparent that emergency measures would have to be taken to accommodate the 1,014 students who had registered.

Hasty negotiation with officials at Southern Tech and the City of Marietta ensued, and temporary arrangements were made to hold

classes at Southern Tech. Most of Kennesaw's administrators and office staff used donated office space at Banberry Elementary School.

As congenial as these relationships were, the faculty and staff of Kennesaw Junior College were determined to move into their permanent quarters by January of 1967. They rolled up their sleeves and pitched in to install light bulbs, move furniture and wash windows. Some even poured concrete and laid bricks. They accomplished their goal — classed began on January 9 — but the campus was far from complete.

Only three of the original eight buildings were finished at this point. The Library did not open until mid-March and students had to go to the physics lab for any books they needed during the first quarter. Those taking physical education classed tumbled in the hallways of the Social Science Building until the Physical Education Building opened in June. A sea of slick red mud surrounded sidewalks on all sides during the first few months, and although large sections of the 152 acre campus were heavily wooded, no trees, bushes or flowers softened the stark outlines of the buildings at its center.

From the time the college opened, area business and civic leaders and local residents made it clear that although they were pleased to have a junior college in Cobb County, what they really wanted was a four-year liberal arts institution. Officials at KJC had long felt that this was the college's destiny from the start, they had purposefully recruited faculty members with credentials worthy of a senior college, favoring doctoral degrees over years of experience.

The growth in population and sophistication of the surrounding community during the 1960s and early 1970s seemed to warrant a four-year liberal arts college, and several influential state politicians, including Joe Frank Harris (who was then a Cartersville representative), and Joe Mack Wilson and A. L. Burruss (both of whom were members of the Cobb legislative delegation at the time) strongly supported KJC's conversion, but the Regents took some convincing.

It was not until KJC's student leaders joined the cause during the mid-1970s and helped get the general public behind the college that the Regents were forced into action. Members of the Student Government Association went to local shopping centers and collected 10,000 signatures on a petition to support the senior college status

for KJC. They held a rally, distributed "Four Year" T-shirts and lobbied the Cobb Chamber of Commerce for its support.

Finally, the Regents agreed to consider the proposal. After hours of debate, they put the matter to vote on April 14, 1976. Word of their decision was quickly relayed to the KJC campus, where an excited voice startled the lunch time crowd in the Student Center by shouting "We did it" over the public address system.

The college began the conversion process by changing the word "junior" from the name and establishing several baccalaureate programs in September 1977. In June 1980, Kennesaw College awarded degrees to its first four-year graduates, a total of 70 students. And later that year, the college was fully accredited as a four-year institution by the Southern Association of Colleges and Schools.

Meanwhile, something else had happened that was also to affect the future of the college. The portion of Interstate 75 that runs through Cobb County was completed in late 1977, with an interchange located just a few hundred yards from the campus. With Kennesaw College now within convenient commuting distance of a good part of northwest Georgia, the college's growth seemed assured.

Having supervised Kennesaw's transition to a four-year college and the construction of three new buildings, Dr. Sturgis retired in 1981. A nationwide search was launched to replace him, and the Regents ultimately elected Dr. Betty L. Siegel, who was then dean of the School of Education and Philosophy at Western Carolina University. Inaugurated on September 9, 1981, Dr. Siegel was the first woman president in the history of the University System of Georgia.

Although the publicity that accompanied Kennesaw College's elevation to senior-college status prompted a surge in enrollment, both students and faculty continued to hear members on the community refer to the institution as "the junior college" with annoying frequency. By the fall, many attended the bonfire that traditionally marked the end of fall-quarter exams. Perched on top of the pile of rubble that Dr. Siegel ignited that December was a large sign warning, "Don't call us junior anymore!"

In 1983, Dr. Siegel and her executive staff directed the reorganization of the college's long-standing divisions of study into four schools:

- · The School of Arts and Behavioral Sciences
- The School of Business
- · The School of Education; and,
- · The School of Science and Allied Health

Until this point, the college had just one academic dean, but now, each school had its own dean.

Kennesaw College was by now firmly established as a four-year institution. Students from at least nine counties surrounding Atlanta were flocking to the school and demanding additional degree programs.

The mid-to-late 1980s saw the college growing on all fronts in enrollment, in academic programs, in buildings and in stature. At a time when most colleges and universities around the country were finding it increasingly difficult to attract students, Kennesaw College was in the enviable position of being the fastest growing institution in the University System. Enrollment rose from just under 7,000 students in 1985 to more than 10,000 in 1990, and the campus grew painfully crowded.

Luckily, the state funded two new buildings for the college during this time. One to house the School of Education and the Performing Arts that opened in 1989 and another for the burgeoning School of Business Administration, the A. L. Burruss Business Administration/Computer Science Building that opened in 1991.

The college began offering master's degrees in business administration and education in the fall of 1985. About 300 students enrolled as graduate students that quarter.

The choice of undergraduate majors increased from 11 to 40 as new programs were added in such areas as international affairs, French, Spanish, communications, art, music performance, professional sales and public and social services.

In 1988, while preparing to celebrate the 25th anniversary of its founding, Kennesaw College added the word "state" to its name to

better define itself as a four-year, public institution. That year, the college also discontinued all of its two-year associate degree programs, except the very popular nursing program.

Kennesaw State College greatly expanded the service it offered to the community during this time.

In 1987, the School of Business established the Kennesaw State Family Business Forum, one of the nation's first college-based programs for family run firms in North Georgia. The forum is a paid membership organization that offers family business owners and principals a rare chance to network with their peers and hear experts address issues unique to family businesses during quarterly meetings. In recent years, the number of services KSC offers to family businesses has expanded further. The college now has a Family Enterprise Center that conducts research, provides training, collects articles and papers written about family businesses and recognizes the state's expanding family run firms through the Georgia Family Business of the Year Awards program.

In January 1991, the School of Business established the Kennesaw State Econometric Center, designed to proved timely economic data to the metropolitan Atlanta business community. The center's monthly survey of area purchasing managers, a good indicator of the health of the local economy, is carried in the Marietta Daily Journal.


Eager to spread word of Kennesaw State College's story far and wide since her arrival, Dr. Siegel had filled her calendar with speaking engagements both in the metropolitan Atlanta area and around the country. This practice, along with her leadership roles in several higher education organizations, helped to extend the college's reputation far beyond the region from which it draws its students.


In 1986, a group of researchers from Washington's George Mason University included Kennesaw State College in a book called Searching for Academic Excellence, Twenty Colleges and Universities on the Move and Their Leaders. The book gave Dr. Siegel's leadership much of the credit for Kennesaw's momentum as a dynamic institution. The magazine Georgia Trend evidently agreed, placing her more than once on its annual directory of "the 100 most influential people in Georgia."

Dr. Siegel's visibility as an educator also played a major role in U.S. News & World Report's inclusion of Kennesaw State College as one of the nation's top "up and coming" colleges in it's "1990 Guide to America's Best Colleges." The rankings in this annual guide are based on a nationwide survey of officials in higher education conducted by the magazine. "Up and Comers" is those institutions that are judged by their peers to be advancing more rapidly based on recent educational innovations and improvements. The surveys continued to identify Kennesaw State College as a "rising star of education" in 1991 and 1992.

Kennesaw State's graduate program offerings have grown dramatically during the past few years. The School of Business Administration now has the second largest MBA program in the state and students are able to choose between concentrations in business administration, business economics, information systems management, entrepreneur ship, finance, human resources management and development, and marketing.

During 1993, two more degree programs became available: the master of accounting and the MBA for Experienced Professionals.



HISTORY OF THE MICHAEL J. COLES SCHOOL OF BUSINESS ADMINISTRATION

The Michael J. Coles School of Business Administration at Kennesaw State College is committed to actively addressing the ever changing needs of society and the environment of business. One of the main goals of the School of Business Administration is to give students an insight into the fundamental principles and practices that may be applied to the managerial and operational functions of a modern business environment.

The Michael J. Coles School of Business Administration is one of four academic schools at Kennesaw State College. The school was created in 1983 and now has the largest enrollment of the four schools. Over 3,000 of the more than 12,000 students at Kennesaw State College are business majors. With over 500 students seeking MBAs, Kennesaw State College has the second largest MBA program within the State of Georgia. The MBA program now includes the MBA for Experienced Professionals and is in its second year having enrolled more than 100 students.

The School of Business Administration was organized into five departments in the summer of 1990. Those five departments are:

- The Department of Accounting
- The Department of Decision Science and Business Law
- The Department of Economics and Finance
- The Department of Management and Entrepreneurship
- The Department of Marketing and Professional Sales

Also during the summer of 1990, on July 1, Dr. Timothy S. Mescon, Ph.D. was appointed to become Dean of the School of Business Administration.

There is an emphasis on real-world involvement that extends from the faculty to the students. Dean Mescon, for example, co-authors columns in The Atlanta Business Chronicle and in Delta Airline's Sky magazine and a finance professor hosts a radio investment advise show. Two other faculty members have formed Kennesaw State Econometric, which distributes data used as economic indicators in reports by Atlanta's news media. In addition, approximately 80% of

the full-time faculty in the School of Business Administration hold either the Ph.D., D.B.A., or J.D. degrees.

A team of scholars who visited Kennesaw State College in the fall of 1993 to review the college's application for full accreditation by the American Assembly of Collegiate Schools of Business has recommended that School of Business Administration receive this affirmation of both standards and quality. Only about 300 of the nation's 1,800 business schools can claim this distinction. The AACSB will make its final decision in April.

On February 25, 1994, the Kennesaw State College School of Business Administration became the Michael J. Coles School of Business Administration. This change was made to honor Mr. Michael J. Coles, a local entrepreneur and self-made millionaire, who founded The American Chocolate Chip Cookie Company. Mr. Coles has made countless contributions to the community and to the Business School at Kennesaw State College.

The school has come a long way since its inception in 1983, but Dr. Mescon is not one to rest on his laurels. He said, "We don't want to have the best programs in the state — we want to be world class."

DESCRIPTION OF THE UNDERGRADUATE MAJORS IN THE MICHAEL J. COLES SCHOOL OF BUSINESS ADMINISTRATION

ACCOUNTING

Accounting is the tool that people use to measure and communicate economic information for decision making. The accounting degree program focuses on Financial, Managerial, and Tax Accounting.

ECONOMICS

Economics examine how individual households and firms within the economy operate. The emphasis in Economics is on using analytical methods to determine the most efficient means to reach various goals.

FINANCE

Finance is an analytical discipline dealing with the acquisition and distribution of funds. Included in a Finance degree are comprehensive studies in the areas of Accounting, Economics, and Investments.

MANAGEMENT


Management is the process of planning, organizing, staffing, directing, and controlling activities in an organization which will result in the achievement of a common goal. Within the degree program of Management, one of four specialized tracks may be chosen: Human Resource Management and Development, Business Communication, Informational Systems Management, and Small Business Management and Entrepreneurship.

MARKETING

Marketing is concerned with the development, delivery, promotion, and exchange of a company's goods and services to its final customer. In addition to a general Marketing program, one of three specialized tracks may be chosen: Professional Selling, Promotional Communication, and Retail Management.

PROFESSIONAL SALES

Professional sales is the most common entry level position in many companies for college graduated and consequently, there are more job openings in professional sales than in any other marketing area. The focus of the Professional Sales degree program is on business to business or organizational marketing.

THE HISTORY OF KAPPA SIGMA CHI COLONY

On May 13, 1992, Director of Chapter Services, C. Dean Ferguson and Southeastern Regional Director, John A. Watton visited with Dean Timothy S. Mescon to investigate the possibility of starting a chapter of Delta Sigma Pi on the Kennesaw State College campus. In probably one of the shortest expansion visits in the history fraternity (10 minutes), Brother Mescon gave his permission to start the chapter during the upcoming Fall Quarter 1992.

During the summer of 1992, John Watton worked with Dean Ferguson in planning a recruiting schedule for the Fall Quarter 1992.

On September 22, 1992, The Central Office of Delta Sigma Pi mailed 1057 letters to students of the School of Business inviting them to the first recruiting function. During this meeting held on October 1, 1992, members of the Atlanta Alumni Chapter were in attendance to help with the recruiting efforts.

During the next meeting on October 8, 1992, the group conducted an organizational meeting. At this time, they decided to formally petition The International Fraternity of Delta Sigma Pi for a chapter charter. A letter of intent was written and mailed to The Central Office. The group voted to approve the name Kappa Sigma Chi for the colony's name that represented the KSC of Kennesaw State College. The first officers of the group were: President, Karen Dugan, Senior Vice President, Arne Irwin, Vice President for Chapter Operations, Derrick Lowery, and Secretary/Treasurer, Pamela Byers.

During the first month of operation, Dale Clark, the new Director of Chapter Services, visited the chapter on October 20, 1992, and provided the chapter many ideas on the most important activity they needed to concentrate on — recruiting. With Kennesaw State College being a 100% commuter college, the original group found this task to be quite challenging.

In November 1992, colony President Karen Dugan, Vice President for Chapter Operations, Derrick Lowery and Southeastern Regional Director, John Watton met with the Kennesaw State College Student Activities Committee to receive official approval from the college to operate. After a presentation to the group, the committee voted unanimous to recognize the group as a viable student organization.

Also during the first quarter, the chapter participated in the Southeastern Regional Conference and the Atlanta Alumni Chapter's Founders Day celebration.

On January 20-21, 1993, Chapter Consultant James E. Leingang visited the group. During his visit, he was able to visit with each chapter officer and help them in providing organizational structure to the group.

During Winter Quarter 1993, the colony participated in a variety of activities while continuing to recruit new members. Some of these early activities included a blood drive, participating in the Georgia Special Olympics with the Atlanta Alumni Chapter and the two local collegiate chapters (Kappa Chapter at Georgia State University and Pi Chapter at The University of Georgia), a Super Bowl party, a ski weekend at Ski Beech, North Carolina, several car washes and an Atlanta Braves baseball game with the Atlanta Alumni Chapter.

During August 1993, Senior Vice President, April Satterfield (who was initiated by Epsilon Chi Chapter at Georgia Southern University) and Treasurer, Pam Byers, was able to attend the Grand Chapter Congress in Anaheim, California. At this meeting, the two were able to learn many ideas that helped the colony during the following academic year plus experience the activities of the national fraternity.


During the 1993-94 academic year, the colony's activities focused on the main goal of achieving collegiate chapter status. While continuing to recruit new members, the overall quality of activities in several areas improved. In the area of community service projects, the colony provided hot Thanksgiving dinners for 75 local homeless people, participated in the Georgia Special Olympics for the second year in a row and helped with visually impaired students by reading textbooks to them. They have had an extensive professional calendar including a tour of The CNN Center and speakers on subjects ranging from international business affairs to entrepreneurship. They also had 10 members participate in the OTiS school held in Atlanta in October 1993.


Participation and enthusiasm improved by the creation of the Kappa, Sigma, and Chi spirit teams. Many of the social activities have transformed into team competition activities.

During the Winter Quarter, 1994, the colony had nine members go to Colorado for a ski weekend held over the Martin Luther King holiday. They published the first issue of the chapter's newsletter during this quarter. With reference to Kennesaw State College's mascot, The Owl, the newsletter is titled "HOOT & HOLLER, The KEXpress".

The colony is installing some traditional events into the group. They are hosting an annual White Water Rafting Trip on the Ocoee River in Tennessee during May 1994. This is the site of the 1996 Olympic White Water rafting competition. In May 1994, they are sponsoring a Business Professor of the Year Award. During this event the faculty will be treated to gifts and lunch with a presentation ceremony of the Business Professor of the Year Award.
