#### HISTORY OF THE UNIVERSITY OF CALIFORNIA, LOS ANGELES - UCLA

The University of California, Los Angeles was one of the first institutions of higher education formed in the state of California. It is the first branch, and the second school, of the University of California education system. The "Southern Branch" of the University of California was singed into state legislation on May 23, 1919.

The idea for an institution of higher education to be formed in southern California began in the 1880's. With a population of 11,000, Los Angeles was a small town trying to convince the state to form a second State Normal School based on an existing school in San Jose. In March of 1881, the state approved the idea and the creation of a new school in Los Angeles began. Over 200 citizens contributed capital to purchased land to build the school. In 1882, the school welcomed its first students.

Within the next 25 years, the small town of Los Angeles had grown to a population on over 350,000, and its small school had exceeded its capacity. In 1914, the school was moved to a new location at a Hollywood ranch off of a dirt road, present day Vermont Avenue.

The current Director of the school, Ernest Carroll Moore had visions of expansion in mind. And, in 1917 he proposed to the state that his school become the first branch school of the Berkley based University of California. Two years after his proposition, California Governor William D. Stephens signed the legislation, on May 23, 1919, that marked the creation of what we now know as UCLA. But, at the time, this new university was referred to as the "Southern Branch" of the University of California and offered two years of instruction in the Letters and Science. Soon

after its creation, the "Southern Branch" added third and fourth year classes to its program. The first graduating class consisted of 300 students in 1925. And two years later it received its official name, The University of California at Los Angeles.


Still located near Hollywood, the population of UCLA continued to increase. It became obvious that a new home would be needed for UCLA. On, September 21, 1927, Director Moore broke ground on the permanent home of UCLA in Westwood. The four original buildings, Royce Hall, Powell Library, Haines and Kinsey Hall, were built and hosted over 5,500 students in its first year.

The first priority after the move to Westwood was to establish a graduate curriculum, essential for any major university. The Regents established the master's degree at UCLA in 1933 and, three years later, the doctorate. UCLA was fast becoming a full-fledged university offering advanced study in almost every field.

Los Angeles and the University nurtured each other through the years, and both experienced phenomenal growth and development during the next half century. UCLA's most spectacular period of growth occurred in the 25 years following World War II, when it tripled its prewar enrollment of 9,000 students and undertook what would become a \$260 million building program that included residence halls, parking structures, laboratories, more classrooms, service buildings, athletic and recreational facilities, and a 715-bed teaching hospital which is now one of the largest and most highly respected in the world.





#### HISTORY OF THE DEPARTMENT OF ECONOMICS

The Department of Economics within the College of Letters and Sciences at the University of California at Los Angeles made its addition to the university in the 1940's offering students the opportunity to pursue insights in the field of economics and international economics. UCLA furthered its program within the department with the expansion of the study of business economics in 1983 by Harold Demsetz, and a minor in accounting in the 1990's.

developments Many occurred since the commencement of the economics department since the 1940's. Moving from a small building at Dodd Hall to the relocation to Bunche Hall in the 1960's not only proved a change in the location of the department but also the beginning of massive changes in all The economic curriculum aspects. began to focus more on econometrics and mathematics, the notion of marginal thinking was exercised more often in courses, and the impact and development in computing and technology aided to enhance a different perspective. Through the diverse time periods since the beginning of the department, the economics program has advanced and evolved to cater to the requirements of the changing world.

The Department of Economics has set goals to give students the basic economic intuitions into critical business issues, such as asset valuation in financial markets, strategic competition, and the internal organization of a firm. The program applies theoretical rigor to practical business issues as well as offering opportunities to experience a more interactive style of learning. The courses in financial markets present

models of the markets that economists have developed, and the conclusions of those models, and how those models can be used in business.


The program does not duplicate traditional business school undergraduate curriculum. Students are exposed to a narrower range of business school courses, mainly accounting and finance, but gain a much broader background in a variety of topics and disciplines. The accounting courses to prepare for the CPA examination are available through the Minor Accounting offered by the Anderson Graduate School of Management.

To further recognize the high academic quality of the UCLA Department of Economics our faculty range from all over the nation from New Zealand to Japan to Brazil, bringing an international perspective to economics. Prestigious economists such as Jack Hirsheiffer made UCLA famous in his price theory and economics of the marketplace. Our faculty has housed many scholars such as Arnold Harbinger and Lloyd Shapley who are members of the National Academy of Sciences, and Hirsheiffer who is also the Vice President of the American Economic Association.

With an increasing number of students applying for the majors of Economics, Business-Economics, and International Economics each year, the Department of Economics at UCLA provide proves to an excellent background for those seeking a career in management consulting, investment backing, financial analysis, and accounting.

#### THE HISTORY OF LAMBDA ALPHA EPSILON COLONY

The history of the Lambda Alpha Epsilon Colony began with three secondyear UCLA students: Tony Yu, Christine Lee, and Dana Matsuno. Tony, Christine, and Dana laid the foundations for establishing the Colony long before the official Spring Quarter founding date, March 1, 1999. Tony Yu first heard about Delta Sigma Pi from another second-year student from USC, Bonnie Chiu. The tales of brotherhood and professionalism so fascinated Tony that he eagerly shared the idea with his good buddy Dana Matsuno. Together, Tony and Dana saw the potential of a business fraternity at UCLA and they gradually accumulated all of the necessary information from both the UCLA administration and the DSP Central Office on how to start a fraternity colony. Along the way, Christine Lee joined the duo and contributed her energy and creativity to help establish the Colony. Together, Tony, Christine, and Dana envisioned a business fraternity at UCLA that would provide UCLA Economics students with a family of brothers as well as a wide network of future business contacts. These three original founding fathers of the Colony have dedicated hours upon hours of hard work to establish one of the fastest growing fraternities on the UCLA campus.

Christine, Dana, and Tony first conducted an Informational Meeting in order to provide the university students with a glimpse of what Delta Sigma Pi had to offer. The Info Night drew an attendance of over fifty UCLA students and about thirty USC, UCR, LMU, CSULB, and CSUN Delta Sigma Pi brothers. Assistant Dean of Students, Dean Nelson also attended this historical meeting to offer her warmest regards. After that first Info Night, an astonishing 40 UCLA students applied to

join the Colony. Eager to expand the Colony but also wishing to retain the quality of the organization, interviews for membership were conducted by Tony, Christine, and Dana for four consecutive hours each day for two days. Once the dust settled, the Lambda Alpha Epsilon Colony had expanded to 34 members strong, a tenfold increase! Elections were conducted and a Colony Executive Board was in full operation soon after.

The 34 Colony members accomplished an impressive list of activities in a span of seven academic weeks in that Spring Quarter. Professionally, the Colony conducted a resume building workshop and began developing business contacts for future events. The Colony also raised money with two fun TV tapings. In serving the community, the 34 Colony members participated in the AIDS Ride to help setup for this annual national marathon. However, the most important events for the Colony were the social events that facilitated bonding between all of our members. These social events included a Welcome Picnic at the park, End of the Quarter Banquet, as well as other unofficial gatherings. Each officer of the Executive Board planned all of the events from scratch and executed them with much success. The 17 officers of the Executive Board deserved much admiration and gratitude.

From the outset, Tony, Christine, and Dana planned to develop the Colony into a chapter within a year's time, or as close to that as possible. That goal prompted a decision among the 34 members to recruit more UCLA students to help share the increasing workload. Recruiting Week began on the second week of Fall Quarter with our 2<sup>nd</sup> Info Night, Beach Social, Professional Speaker Event, and a final


Pizza Social Night. More than eighty UCLA students attended each of our carefully planned recruiting events. Applications were distributed and interviews were once again conducted, this time with the help of everyone in the Colony. After a whole week of recruiting, thirty four more UCLA students were selected to join our Colony, increasing our membership to a grand total of 68. No one in our Colony expected this exponential growth, but everyone enjoyed our heightening success.


68 Colony members collaborated to drive the Lambda Alpha Epsilon Colony to another level of excellence and success in the Fall and Winter Quarters. In two quarters, our Colony invited a panel of speakers from Price Waterhouse Coopers, Deloitte & Touche, and contacted other Big 5 firms for possible future seminars. Our Colony also Trick o' Treated for cans in our Canned Food Drive, raising over 500lbs. of canned goods. Our 68 members raised over \$3,000 by participating in two TV Tapings,

a football staffing event, and our Service Auction. All of our hard earned money will help fund our future installation banquet. Our officers also planned exciting social events, namely our Big Bear Ski Trip and the Charity Swing Dance. Both social events provided the old and new members with the opportunity to become one unified Colony body.

The last few weeks of Winter and ten weeks of Spring Quarter will bring much excitement and anticipation for our Lambda Alpha Epsilon Colony. After dedicating so much of our efforts to our chartering goal, we are all so excited to be only steps away from pledging and installation. All of our Colony members have bonded over the past eleven months through our journey of uncertainty and struggle to become a chapter. However, our 64 current members now await to realize our initial dream, the dream to become the official brothers of the Delta Sigma Pi Professional Business Fraternity.


