

With pleasure, I would like to record my support for the petition submitted by the students of the Rhode Island Colony at the University of Rhode Island, Kingston, to charter a chapter of Delta Sigma Pi. During the past year, I have been excited to see the Colony's growth from an initial idea to a functioning organization. While they may have experienced a few operational difficulties along the way as they began learning our policies and best practices, the Colony demonstrated a remarkable ability to continue to succeed and grow. A number of the officers in particular have been impressive in fulfilling their responsibilities and leading by example. They have demonstrated a profound commitment to the fraternity and this dedication has helped spread excitement and engagement to the general membership. The History of the University of Rhode Island

Introduction:

The University of Rhode Island is a public university helping students pursue a higher education in their seven academic colleges. The University of Rhode Island's main campus is located in Kingston, Rhode Island spanning across 1,250 acres, which is only thirty miles away from their Providence campus. In 1888 John H. Washburn, who was the president of the State Agricultural School began to organize the school which had then opened on 1890. Two years later in 1892, The University of Rhode Island was founded and moved from Oliver Watson Farm to their current location in Kingston.

The University of Rhode Island currently enrolls 13,831 undergraduate students and 2,972 graduate students (2015). Although about 57% of the students enrolled at URI are from Rhode Island, the other 47% are from 66 nations and 38 US states and territories.

The University of Rhode Island has been authorized by the state to grant bachelors, masters, and doctoral degrees in 80 undergraduate and 49 graduate areas of study throughout our seven academic colleges.

Accreditation and membership:

January 23: Speaker- Interview prep with Schneider Electric




January 25: South Kingstown Animal Shelter






