Provincial Goals

The following are the goals that I outlined in my platform for office and hope to achieve during this biennium.

CEI performance – 100% of chapters with 90 points or more for the 2006-2007 year

The Province as a whole is performing well, with 60% of the chapter tracking to achieve the expected 100 points and 30% expected to achieve my goal of 90 points. As my overall goal is to achieve this level of performance by the end of the biennium, I feel that with this intermediate benchmark the goal is well within reach.

Awards – 100% chapter participation at 2007 Grand Chapter Congress

Participation in the Collegian of the Year program was not what I hoped it would be with nine chapters failing to report their nominee. The promising aspect was quality of applications submitted. The leadership team has agreed that while applying for awards is an important step, we want to ensure the merit of the winners. The focus is on operational soundness that will in turn lead to the quality that being sought.

LEAD/Provincial/Congress attendance – 100% chapter participation at all 2006-2007 conferences Location and distance unfortunately directly affect participation and attendance. With this fall's LEAD school was on the western side of the province, it was poorly attended by the chapters on the eastern side. Several of those chapters were able to attend LEAD schools in other provinces. The Provincial LEAD and Council meeting will be held in a more central location and should be well attended.

Expansion – 2 strong opportunities in each region and 1 colony resulting in a new or reactivated chapter by Congress 2007

Only one school has been contacted for an expansion opportunity (University of Minnesota, Duluth). No reply has been received from the school. The Central Office also received an inquiry from Carroll College in the Great Lakes Region. The interested students have received permission from the school to start the process.

Discipline Issues

There have been several minor issues with a few chapters within the province, but all were handled without major incident.

Colonies

Both colonies are struggling at this point. Most of the Nu Theta Xi colony as dropped out of the process. Several alumni have offered help, but the issue remains the members' willingness to do the work. The Alpha Sigma Omega colony is existing. While there is no back slide, there is also very little forward progress.

General Comments

The Province is doing well as a whole. Attendance at provincial and national events is amazing and the brothers who attend have their views of the fraternity forever altered and their experiences are enhanced. These brothers become the best marketing force we have for future events and for the Fraternity as a whole. It is my hope to mobilize and empower this force to do just that. With the force in place, the accomplishment of our goals will happen.
