Motion:

Proposal submitted by Joseph O'Brien, South Pacific RVP.

These changes are designed to help streamline the elections of our regional officers and strengthen the regions. The first change deals primarily with the election of the Regional Vice Presidents as stated in the National Bylaws, Article VIII, Sec. 3, Election and Tenure of Office. The election of the officer would change so that it would be held at the Provincial Council meeting held in GRAND CHAPTER CONGRESS years with the RVP taking office on July 1. The new section would read: "All Regional Vice Presidents shall be elected by the chapters in good standing in their respective regions at the Provincial Council Meeting prior to GRAND CHAPTER CONGRESS. They shall take office on July 1 of that year and serve for a period of two (2) years and until their successors are elected and duly qualified. Regional Vice Presidents may serve four (4) consecutive elected terms.

South Pacific RVP Joe O'Brien moved. Phoenix Alumni Chapter seconded the motion. Discussion was held.

Lambda Sigma moved to call the previous question. Lambda Mu seconded the motion. The motion passed.

The original motion failed.

Motion:

Proposal submitted by Joseph O'Brien, South Pacific RVP

This change would be to the Policy and Procedures Manual, Sec.L, Policy 15, B – Campaign Policies. The change would be to allow duly qualified candidates the ability to contact chapters and schedule time for one (1) visit with them. This time would be a chance for the candidate to put forth themselves as a viable candidate and where the chapter could pose questions and get answers. Also, an open floor caucus would be allowed as a chance for all of the candidates to talk to the chapters and answer any questions. This would be a one-day event held within the region (or Province depending on the situation) to encourage greater participation by the individual members of the chapters in the election.

South Pacific RVP Joe O'Brien moved. Epsilon Theta seconded the motion. Discussion was held.

The original motion passed "in concept" as the Board of Directors is already reviewing campaign policies.

costs of the twice yearly Provincial Leadership team meeting.

Mu Chi moved to amend the motion to strike "\$50.00 for the 2002-2003 fiscal year" and replace with "amount for the 2002-2003 fiscal year be pro-rated by size of chapter in a tiered format by size. Chapters of 1- 25 members would pay \$50, chapters of 26-75 members would pay \$75, chapters of 76-100 members would pay \$125 and chapters of 101+ would pay \$150".
