INTERNATIONAL FRATERNITY OF DELTA SIGMA PI, INC. SOUTHERN PROVINCIAL COUNCIL MEETING MINUTES MARCH 2, 2019 - ATLANTA, GEORGIA

The Southern Provincial Council Meeting of the International Fraternity of Delta Sigma Pi, Inc. was called to order according to Ritual at 2:03 PM on Saturday, March 2, 2019, by Southern Provincial Vice President Carrie Burns at the Atlanta Marriott Buckhead Hotel in Atlanta, Georgia.

At this time, Burns relinquished the chair to Chancellor Simmons, who introduced Secretary Barry. Barry then conducted the Roll Call of Delegates and announced 53 delegates present and eligible to vote. Kappa Psi moved to adopt the roll of voting delegates. The motion was seconded by Columbia and adopted. See **Addendum A**.

Theta Sigma then moved to adopt the Agenda as presented. The motion was seconded by Omicron Pi and approved. **See Addendum B**.

Kappa Pi moved to receive the printed Official Reports as distributed to the delegates. Jacksonville seconded and the motion was adopted. **See Addendum C**.

OLD & NEW BUSINESS

Chancellor Simmons then noted there was no old business and moved into new business.

Kappa Tau then moved the 2019-2020 Provincial Budget. The motion was seconded by Zeta Lambda.

The 2019-2020 Provincial Budget was then adopted. See Addendum D.

Chancellor Simmons announced that straw polls (non-binding unofficial votes) would be taken on the proposed ritual legislation following a 30 minute town hall. Motioned by Theta Sigma and seconded by West Palm Beach alumni.

Kappa Tau asked if these would be able to be further revised.

- Grand President Smith clarified that North Central is able to make amendments to the proposal.
- These could be further amended at GCC.
- Brother Malice said that some typos have already been amended.

Proposal 1: Inclusive language of initiation ritual

- Pi strongly in favor, feels that all should feel included.
- Kappa Pi raised concern that ritual is not completely gender neutral (in use of "brother").
 - Clarification from Vitale that the proposing chapter specifically wants to keep "brother".
- Gamma Lambda agreed that it would be confusing to go completely gender neutral.
- St. Pete/Clearwater raised concern about "brother meet brother" line.
 - Brother Malice supposed that they may have not been able to come up with a good adjustment to that line.
 - Brother Smith recommended raising this concern at GCC.
 - Kappa Tau agrees that this line should be looked at because the current form clarifies to only use grip with brothers.
- Brother Reeves raised concern about "makes a man a man" line.
- Brother Borden asked brothers to consider context of words in the English language.
- Kappa Pi concerned that wording of proposal changes presentation and may make ceremony less solemn (such as in "rise as able" in all cases).
 - Theta Sigma noted that brothers should be aware of any disabilities and this calls attention to a disability.
 - Gamma Lambda argued that "if able" is considerate and that fraternity cares about all brothers.
 - Kappa Pi concerned that "if able" gives neophytes option to not rise.
 - Kappa Tau not concerned about some choosing not to rise.
 - Theta Sigma noted we should be considerate of other brothers even if we cannot relate.
- Brother Borden noted that we should be considerate of brothers without formally changing the ritual.
- St. Pete/Clearwater asked if the board can make changes to the guidance in italics to handle inclusivity.

- GP Smith clarified that this would be possible, and advised chapters to consider all potential amendments and to let PVP know.
- Atlanta asked if legal council advised that we look at ritual.
 - GP Smith clarified that legal council has not looked at ritual but board is considering potential risk in the current ritual.
- Gamma Lambda asked why we are doing a discussion like this.
 - Burns clarified that this provides advice on changes to the proposing province but this is not a binding vote, official vote to change ritual will be at GCC.
 - GP Smith reminded that discussion today does not change what goes to GCC but gives chapters chance to discuss what amendments they want to propose.
- Kappa Pi asked when chapters would receive passed proposals so they have time to discuss as chapters, and passing percentages in North Central.
 - GP Smith answered that this would be sometime this spring (around April 15), and suggested that some chapters hold special meetings over summer to discuss.
 - Approximately 95% (1) and 75% (3)
- Pi noted that society has changed since the last GCC and expects most in the room to be in favor.

Proposal 3: Unnecessary language in initiation ritual

- St. Pete/Clearwater noted that there are lies in part 1 of initiation that this proposal would fix.
- Omicron Pi said that initiates have gone to chapter to ask if they could have actually been kicked out which this would fix.
- Theta Sigma wanted clarification on a detail, given thumbs up by GP Smith.
- Kappa Pi asked if questions would be limited.
 - GP Smith clarified that chapters can still use pledge manual questions.
- Theta Sigma asked for any negative comments from North Central discussion.
 Brother Malice said there were only a few small typos and fixes.
- St. Pete/Clearwater does not like "sit upright", especially for honorary/faculty.
 - Brother Reeves asked if the proposal fixed that, clarification given that proposal only concerned with part 1.
- Brother Borden concerned about laughter given to pledges, wants chapters to be concerned with behavior along with concrete ritual changes.
 - Gamma Tau noted that brothers should be reminded to be serious and respectful.
 - CONSIDER AS BOARD RECOMMENDATION.
 - Brother Vitale noted that "sit upright" may be outdated.

Chancellor Simmons called for a straw poll by placard on proposals.

• Proposal 1: 36 in favor (68%)

• Proposal 3: 44 in favor (83%)

Chancellor Simmons asked for recommendations on provincial budget surplus.

• Historically, 75% go to next year's LEAD fund, 25% goes to endowed funds.

Atlanta motioned to suspend the rules for a 5 minute discussion. Seconded by Pi.

- Atlanta does not like taking provincial money to benefit a fund for a specific region/province, surplus should be used to benefit entire region.
- West Palm clarified that Cookson fund has been endowed.
- St. Pete/Clearwater mentioned how much it helped Rho Psi for their travel fund to receive support.

Columbia motioned to suspend discussion. Seconded by Kappa Pi.

Birmingham noted that some surplus already lowers LEAD costs and we do not know what surplus would be. St. Pete/Clearwater agreed that we would not get much surplus to go towards GCC.

Gamma Lambda motioned to write a check to GCC delegates to be used for registration prices prior to the beginning of GCC. Seconded by Chi Omega.

- Kappa Pi said that it would not make enough of a difference.
- Rho Psi said that money should not be given prior to event because it is to be used for event.
- Columbia does not believe cost of individual checks would be worth small reward.
- Gamma Lambda asked if this could be in the form of a promo code and is not afraid of CO billing chapters who do not use money appropriately.
- Xi Sigma agrees that it is hard to pay up front even if they know reimbursement money is coming.
- RVP Hill asked Brother Borden to speak.
 - Brother Borden does not believe this is legal/possible, ED Shilling agrees
- Kappa Pi asked for typical surplus amount.
 - Burns answers no more than a couple thousand.
 - Kappa Pi noted that this would be about \$11 per chapter.
 - Beta Gamma said that the amount of money we are discussing is not worth the effort of sending out checks and wants to put money into scholarships.
- Zeta Upsilon recommends that we amend the proposal.

Gamma Lambda motioned to amend proposal to prorate the registration rate and to add to travel fund. Seconded by Kappa.

• RVP Hill noted that chapters pay into funds, it is not paid into by Central Office.

Theta Sigma moved to vote on amendment to proposal. Seconded by Birmingham/Magic City.

Vote by acclamation: motion fails

Kappa Pi moved to vote on original proposal. Seconded by Louisville.

Vote by acclamation: motion fails

Columbia motioned for 75% towards LEAD, 12.5% for Southern Provincial Ashley Harrison Memorial Scholarship, 12.5% for Dr. Philip H. Turnquist Southern Provincial Scholarship. Seconded by Tau Phi.

• Kappa tau asked which of these benefit entire province. Chancellor Simmons noted that these both benefit entire province

Kappa Pi moved to vote. Seconded by Beta Eta

Vote by acclamation: Motion carries

Zeta Lambda then moved the Location and Date of the [+2 years] Provincial Conference and Council Meeting. The motion was seconded by Beta Lambda.

Rho Psi motioned to replace Norfolk with Orlando. Seconded by Chi Omega .

- Burns noted that Orlando proved to not be feasible last year
- RVP King mentioned that there is a beach near Norfolk and would be great exposure for new chapter Chi Omega
- Chi Omega noted flooding concerns in spring

Gamma Lambda motioned to amend to Orlando to Tallahassee

- Beta Lambda clarified if these are official votes or just suggestions
- Beta Lambda also said that a TN location would be more fair for other chapters

Gamma Lambda moved to vote. Beta Gamma seconded

Vote by placard: Motion fails (21 for, 40%)

lota Mu motioned to replace Norfolk with Raleigh, NC

• Iota Mu said Raleigh is a better midpoint.

Gamma Lambda moved to vote. Seconded by Beta Eta.

Vote by placard: Motion carries (39 for, 74%)

Kappa Pi moved to vote on location. Seconded by Memphis. Vote by paper ballot: Chattanooga/Knoxville (22) , Raleigh (20), Memphis (11)

Regarding dates, two chapters mentioned that Date 3 was Spring Break Pi moved to vote on the date. Beta Lambda seconded. Vote by paper ballot: Date 2 (23), Date 1 (21), Date 3 (9)

The Southern Province and Fraternity as a whole have had a pretty exciting year, including the installation of the new Chi Omega chapter at Old Dominion in the Mid-Atlantic Province and reinstallation of the Omicron chapter at Vanderbilt University in the Mid-South Province. The South Atlantic Province had a very successful Area Conference at the University of Miami and we successfully ran the first Presidents' Academy in St Louis. We are close to 100% on placement of District Directors and all committee chairs are in place to start working on progressing professional and alumni development. Risk management concerns continue to be an issue at a number of chapters. Working to instill the proper Delta Sigma Pi procedures and transitions and minimize potentially harmful "traditions" is a big focus of the SoPro leadership team as well as enhancing and improving upon ritual. This is not meant to negatively impact the Brotherhood at the chapters, but to encourage positive methods of pledge and Brother education and grow strong leaders with strong morals and character.

 - COY We had 2 chapters not submit (Eta Kappa & Alpha Lambda), but still close to 100%, last year we only had 1 so need to make sure to keep an eye on that;

we had 13 incomplete applications this year, 1 more than last year, gotta get those applications in to be eligible

- Increase number of chapters taking advantage of Leadership Foundation scholarships
- Increase attendance at provincial/national events
 - Birmingham LEAD had solid numbers with very few issues overall and a great response from surveys
 - Atlanta Provincial numbers are low right now, great opportunity to network and a relatively easy spot to get to so working on encouraging early registration

Regional Summaries

Atlantic Coast Region - Trina Kirk

• The Chapters of the Atlantic Coast Region continue to work on making themselves better than they were the day before. They continue evaluate their progress on a daily basis, and make changes to make their Chapter more efficient. We are in the final stages of bringing back Joint Initiation to the Atlantic Coast Region for the six collegiate chapters and two alumni chapters in the region. We are looking to hold this every Spring Semester. The Fall Semester would be single Chapter Initiations or possibly a couple of mini Joint Initiation of two or three Chapters only.

Central Gulf Region - Holly Vernon

The Central Gulf Region had an overall positive Fall semester. So far, CMP performance is average, with all chapters but one capable of still achieving accredited status if the remaining items are submitted timely. The region fell significantly in COY applications. While all but one chapter submitted a nominee, only two of the five completed their applications. Alpha Sigma leads the region in the number of approved Professional activities with only two left for the Spring and remains the largest chapter in the Region. Beta Lambda is on track to maintain accredited status and continues to be a consistent chapter with CMP and member numbers. Gamma Tau is still struggling with debt to Central Office, but a new District Director has been put in place and actions will be taken to help the chapter get back on track. Eta Kappa won the award for most improved chapter and has grown in their membership. Eta Upsilon leads in community service events with five complete, leaving one remaining for the spring. Tau Phi will not achieve accredited status due to already having three late items but hope that they will strengthen in the Spring and have 100% completion. I hope that the chapters will finish strong in the Spring and prepare themselves for a great turnout in Atlanta for GCC 2019!

Mid-Atlantic - Aimee King
